PUBLIC COMMENT

Some reasons for concerns included school start dates and the difference between Lacrosse and St John harvest times; loss of revenue for SJE student groups along with downtown businesses; and the lost opportunity for all track athletes to practice together with head coach Paul Johnson.

Kelli Melhus moved and John Hergert seconded the motion to accept Roger Beck's letter of retirement. Superintendent Schmick thanked Mr. Beck for his 52 years of service to the St John School District and wished him the best in retirement. All St John board members agreed.

Alan Blumenshein moved and Dallas Loomis seconded the motion to approve the 2019-20 classified contract for Charles Voiselle, Maintenance/Custodial Supervisor for the St John School District. All St John board members agreed.

St John Transportation Supervisor Ken Gering presented proposals for the purchase of two 1-ton buses and one type D bus. Alan Blumenshein moved and Kelli Melhus seconded the motion to approve the purchase of the 3 buses. All St John board members agreed.

Discussion was held as a follow up to the SJEL Sports Board meeting held February 12th. Items discussed included: possible coordination of school calendars, student participation and possibility of additional games in Lacrosse. The St John and Endicott boards agreed to work with Lacrosse on the school calendar with the understanding that SJE start date may be different from Lacrosse's, depending on harvest progression in the SJE area. The SJE boards also agreed to staying with the current cooperative agreement with Lacrosse and not adding any additional games in Lacrosse with the exception of possibly holding HS baseball games there if Endicott's field is too wet. Director Val Brewer would

like to discuss eligibility requirements and possibly make changes to our current requirements to more align with WIAA's minimum standards. This item will be discussed at the next SJEL Sports Board meeting, currently scheduled for May 21st.

SUPERINTENDENT'S REPORT

Principal Purvine began his report with a tour of the art room to show the boards the recent purchases that Art teacher Travis Echanove has made using the grant monies he received from the Hagan Foundation. Mr. Purvine also provided updates for Character Strong activities, social studies curriculum adoption, NHS Blood Drive and upcoming events.

In the absence of Principal Porubek, Superintendent Schmick provided written updates for the Endicott School that included congratulations to the ESJL volleyball team for being league champions and ESJ receiving the 2019 College Bound Gold Star Award. Also provided updates for athletics, Character Strong activities and upcoming events.

Superintendent Schmick voiced her disappointment with LifeTouch Photography and she will be sending out an email to all families that acknowledges concerns with the company. She also updated the boards of what information OSPI is providing to School Administrators regarding the proposed sex education curriculum that is currently being discussed amongst legislators in Olympia.

Dana Crider provided February enrollment reports along with January financial reports for both school districts. She also provided information regarding the financial impacts of SEBB for both districts.
