The determination for other purposes depends on evaluation of those factors and a power of attorney executed pursuant to ORS 109.056. For special education students, parent also includes a surrogate parent, an adult student to whom rights have transferred and foster parent as defined in OAR 581-015-2000.

## Facilities

It is the intent of the Board to provide and maintain facilities that offer the best possible physical environment for learning and working and to meet the needs of the district's program and services. In the event that permanent facilities are not available, the district may lease or rent space subject to the following guidelines:

1. Facilities must conform to all applicable federal, state and local building codes, health and fire laws, environmental standards, and provisions for accessibility and usability as required by the Americans with Disabilities Act.
2. Available space from local school districts, partnering agencies and other educational entities shall be given preference provided they meet applicable standards for space, efficiency and cost.

## Memorials

The Board will consider the acceptance of memorial funds in honor of persons who have special significance to the students, the ~~district~~ ESD or the community. A room or item may be named for the person in whose honor the fund is created. A memorial plaque may be appropriately dedicated whenever a room or item is designated as a memorial.

Offers of a memorial scholarship or other funds will be submitted to the superintendent together with information concerning the purpose of the memorial and administration of the fund.

The superintendent may receive items as a memorial to a student or person having a special significance to the ESD ~~district~~. Items received as memorials become the property of the ESD ~~district~~.

The establishment of memorial funds will be subject to the following:

- ~~1. Established guidelines from the~~ The superintendent will establish guidelines for the acceptance of memorials;

The superintendent will establish guidelines for the acceptance of memorials;

- ~~2. Consideration to establish of a memorial to be established with private funds shall be requested in writing based upon a written request;~~

The establishment of a memorial with private funds shall be requested in writing.

3. The Board shall make the final determination of the appropriateness of a proposed memorial.
