Differentiated Accountability

Recently Twin Cedars Elementary received its status in regards to Early Literacy Implementation. Twin Cedars, along with all schools in the state, were scored in two categories: Assessment and Universal Instruction. Within these two categories, three ratings are given: Universal, Targeted, Intensive.

In Assessment, Twin Cedars was one of 24 school rated as Universal. This means Twin Cedars is doing a great job assessing and progress monitoring students in accordance with state guidelines.

In Universal Instruction, Twin Cedars was rated as Targeted. Of the 300 school receiving statuses, 253 schools were rated as Targeted. In order to receive an Universal rating we need to raise our FAST proficiency from 66% to 79%. We have several initiatives to help us reach this standard.
