# Minutes of Meeting

#### Twin Cedars Board of Directors September 14, 2015 5:00 PM

he regular meeting of the Twin Cedars Board of Directors was held on the above date.

President Brian Moore called the meeting to order at 5:00 PM. Directors Tom Morgan, Steve Gilkerson, Kelly Carlson, and Steve Hoehns were in attendance. Kim Roby, Dave Roby, Trevor Pinegar, Jacob Clark, Wilma Pinegar, Ashlee Carlson, Paul Haselhuhn, Kim Roby, Dave Roby, Drew Bracken, Jeff Clark, Mandy Reed, Carol Reed, and Karmen Merriweather were also in attendance.

A motion was made by Director Carlson and supported by Director Gilkerson to approve the agenda as presented. The motion carried unanimously.

# **Student Good Conduct Appeal Hearing before the Board**

Drew Bracken of Ahlers Law Firm opened the discussion. He explained that this hearing is for a student discipline appeal. He explained that the Administration would be given 15 minutes to present their case and then the family would be given 15 minutes to present their case. He told the board they would be able to ask questions of both parties after the presentations. He explained that there are only 3 grounds for review: the student did not violate the good conduct rule; the student was given inadequate due process in the investigation and determination; or the penalty is in violation of the Handbook Rule or Board Policy. High School Principal Dave Roby read the FFA instructor's testimony of what took place on the evening of September 2, 2015 at the Pizza Ranch in Pella. Mr. Roby also read the statements from the Pizza Ranch Owners concerning this incident. The board was given copies of these documents. The board asked a question about what the student's first two violations of the good conduct policy had been. The student read a portion of the statement that he had given to board secretary. Friends and family spoke about the student's character.

Drew Bracken then instructed the board to either uphold the decision made by administration or to overturn the decision made by administration.

A motion was made by Director Hoehns and supported by Director Morgan to uphold the decision made by administration to suspend the student from all extra-curricular activities for one year from the date of violation as per the student handbook. **Ayes** – Hoehns, Gilkerson, Morgan. **Nays** – K. Carlson

A motion was made by Director Carlson and supported by Director Gilkerson to approve the August 11, 2015, regular meeting minutes as presented. The motion carried unanimously.

Financial reports were reviewed and filed for audit.

A motion was made by Director Carlson and supported by Director Hoehns to approve the bills as presented. The motion carried unanimously.

#### Communications

There was no communication through the mail or board members.

#### **Administration Reports**

Mrs. Roby handed out a letter that went out to Twin Cedars parents. It is about the Yearly Progress and that Twin Cedars is on the "Schools in Need of Assistance" (SINA). It informs the parents as to why Twin Cedars didn't meet the goals and what steps will be taken.

Mr. Roby shared that Twin Cedars now has possession of the Football trophy as well as the ITEDs trophy from Melcher-Dallas/Twin Cedars game. National Honor Society will be on October 19th at 6:00 in the high school cafeteria. Homecoming is September 25 vs Wayne.

Mr. VanderSluis reported that the latest count is 337. Since 2009, the enrollment has dropped 103 students. This greatly affects the budget. Mark has looked into a couple of floor scrubbers. The current ones are several years old and are starting to need repairs. He got quotes for 2 different ones. The board asked for more information on warranties, etc. MidAmerican was here on Friday checking out the lighting and what will be needed for the replacements. We should be hearing from them soon.
