December 14, 2021

The Pioneer School Board met on December 14, 2021 at 6:30 P.M. at the Pioneer Regional Administration Building. The Board approved of the 2021-2022 SY goals for expenditure categories as required by PL 191-2006 (HEA 1006) with a vote of 4-0.


The Board approved the following donations with a vote of 4-0.


1. Security Federal Savings Bank - \$400.00 for ES clothing closet
