LEASE PROCEDURE AND GENERAL TERMS

- 1. All offers will be calculated and evaluated based on price per tillable acre. Preference shall be provided to those offerors currently paying property taxes to the District. All offers shall satisfy a minimum lease price of \$300 per tillable acre (32.4 acres).
- 2. Following receipt of the offers, the District shall review and consider offers. The District reserves the right to select an offer that is in the best interests of the District. The selected offeror shall enter into a lease agreement with the District

- governing its use and occupancy of the property. The anticipated term of the lease agreement is March 1st, 2023 through February 29th, 2024.
- 3. The interested offeror should satisfy him or herself as to financing, zoning, and other matters of concern before making his or her offer.
- 4. The property is being leased in an "as is" condition. No warranties or representations are being made concerning the condition of the property nor as to compliance with any local, state or federal laws.
- 5. The lease shall be subject to encroachments, easements, reservations, zoning ordinances, and any other encumbrances of record.
- 6. KSI Laboratories completed a soil fertility analysis of the property in December of 2022. Based on the analysis, the district will apply 2.5 tons per acre of lime in February of 2023. The analysis will also establish a baseline for other soil fertility levels; and these baselines must be at or above current levels at the conclusion of the lease.
- 7. Copies of the December 2022 KSI Laboratories soil fertility report are available upon request at District offices.
