7.2 Adopt a Resolution for a Budget Amendment do to Unanticipated Enrollment increase for 2019-20.

Stacy Conrow-Ververis motioned to open agenda item 7.2, Jaime Talbot seconded the motion; Mr.Kinney recommends the board approve the request approve the adoption of a Resolution for a Budget Amendment to address the Unanticipated Enrollment increase for 2019-20 in the amount of \$73,718.44. All in favor, **motion carries 4-0**

7.3. Approve High School Graduation date

Jaime Talbot motioned to open agenda item 7.3, Dan Hazlett seconded the motion; Mr.Kinney recommends the board approve the request made by Chris Clairmont, the 2020 graduation date to be set for Sunday, May 24th, 2020 @ 2PM. All in favor, **motion carries 4-0**

7.4 Approve to move 8th grade students up for High School boys basketball

Stacy Conrow-Ververis motioned to open agenda item 7.4, Jaime Talbot seconded the motion; Mr. Kinney recommends the board to approve a request made by Mr. Quinlan. Mr. Quinlan requested the board to allow 8th grade boys to move up into the high school boys' basketball program pending MHSA approval. The board discussed the number of players for the current season. MHSA rules states that you must have a minimum of 16 players to allow Junior High to compete with High School players. Michelle Parkin motioned to allowing the 8th grade boys to play up only if there are not 16 players, pending MHSA approval. All in favor of the amendment, **motion carries 4-0**

INFORMATIONAL/DISCUSSION

- 8.1 Byron Quinlan discussed with the board the need to pull up 8th grade boys to play high school basketball as we are very short on numbers; at that time Mr. Kinney requested to amend the agenda to make this request action item 7.4
- 8.2 Mr. Kinney spoke on behalf of Dan McGee informing the board that the gym floor crew will be wrapping up the project very soon.

He also said that the Facilities Committee had met and there was discussion on the high school athletic facilities. There are thoughts of updating the crow's nest to make it a more usable space for not only those who work the football games, but for the spectators as well, creating a "cat den" under the crow's nest. Mr. Clairmont informed the board that he would like to look at a proposal for next year for MHSA to allow schools that are involved in a co-ops t move up in classification whereas right now that is not possible.

Stacy Conrow-Ververis motioned to adjourn; Jaime Talbot seconded the motion, all in favor, **motion carries 4-0**. The meeting was adjourned at 6:55p.m.
