DISTRICT GOALS

- **RTI – (Response to Intervention)** When RTI is implemented with diligence, we see much growth. We have worked in the past few years to develop a strong RTI program in all grades and subjects all the way through 12th grade. This is being monitored and continues to be a focus district wide.
- **PLC – (Professional Learning Community)** The PLC Model focuses on 4 questions.
 1. What are the students supposed to know (essential standards)?
 2. How do we know they have learned the standard?
 3. What do we do if they have not learned the standard?
 4. What do we do if they have learned the standard?

DISTRICT GOALS

Essential Standards – These are non-negotiable standards that students absolutely must learn to move forward. These standards are the ones that are discussed in team meetings and are the standards most intervention focuses around. The district continues to work toward developing/identifying these standards for K-12 in major subject areas. The PLC Process and RTI can not take place without the identification of essential standards.

Hampton Elementary is going through their 2nd year of extensive training on with the PLC model and all administrators and many leadership team members have received training toward implementation of the PLC Model. Hampton Elementary was accredited by Solution Tree as a PLC Model School in the 2020-2021 school year.

Hampton High School has begun it's initial year of the PLC process. The entire district continues working with this process, which when done effectively proves to bring teachers together as a team and move student progress forward.

HAMPTON VIRTUAL LEARNING

The Hampton School District maintains compliance with CIPA through the use of a Cisco Web filtering System for off-site filtering of devices and Fortinet for on-site filtering that is provided through the Department of Information Services. The District makes technology and \ or internet access available to students, to permit the student to perform research and to allow students to learn how to use technology. The use of district technology equipment is for education and/or instructional purposes only. The state provides these filters to prevent users from accessing material that is harmful to minors. The district also has local control which enables additional filtering. Students are advised that they enjoy no expectation of privacy in any aspect of their technology use and that monitoring of student device use is continuous.

The District is assessed every 3 years by the Child Nutrition Unit of the ADE when Food Services is accessed. Hampton School District Food Service Director follows the guidelines explicitly. The district over the past years has received a positive report from Child Nutrition. The District has also seen positive reports from the Indistar report and the SHI report every year.

The SHI report - School Health Index - is an assessment that the Wellness Committee completes each year. It assesses the safety, health curriculum, and overall health of our school. The District's School Nurse is very involved in the Wellness Committee activities. The school nurse screens for Vision, Body Mass Index, Scoliosis, and Hearing annually. She of course takes great care of our students and staff needs.

- Current options for the Gifted and Talented student are as follows:
 - GT Enrichment services are provided with Talents Unlimited trained teachers in each class for grades K-6 under the direction of the GT Coordinator.
 - Students in grades 7-8 are provided services in the regular classroom with teachers trained in secondary content training and under the direction of the GT Coordinator.
 - Pre AP/ AP approved courses with AP certified instructors are provided.
 - Concurrent Credit is provided through online classes .
- The Gifted and Talented Testing and Identification process is ongoing in the District.

- Literacy programs include RISE (k-3) which allows students to be taught in a small group. Focus is on decodable books that goes along with phonics and phonemic awareness. We re-test every 9 weeks
- The 3-6 Math/Science teachers are in RISE training which will provide an in depth knowledge related to the science of reading, evidence-based instructional strategies, and making data-based decisions for ALL students.
- 95% and CKLA (phonics program for k-2)
- Interactive Read Alouds (3-6) which are lessons based on texts that help build fluency and comprehension
- AR reading program (k-6) which is connected to our library and we have added laptops in every classroom for students to be able to AR test in the classroom
