9.1 Facility Inspection Tool Report

The FIT establishes a permanent and objective tool to evaluate the condition of school facilities, and all public school districts and county offices of education in California must use the FIT to determine if their school facilities are in "good repair" as defined in Education Code Section 17002(d)(1). The FIT is intended to aid in ensuring that all California school children have access to clean, safe, and functional school facilities. Intended as a visual inspection tool, fifteen components are evaluated as part of the FIT.

9.2 Well Project

The team continues to move forward with the project. They have reviewed the funding application and have identified (3) documents needed to complete the application. The District has provide the documents needed. Once the application packet is complete, it will be submitted for review and approval. The approved resolution will designate the District Superintendent/Principal as the Authorized Representative to make decisions/sign as needed for the well project.

9.3 Bank Accounts

The student accounts at Bank of America have been transferred and combined into one student account at Tri-Counties Bank. Bank of America was charging a

monthly service fee that was negatively impacting the balance of the student accounts – and would not waive the fees. The account at Tri-Counties Bank will not charge any service fees, which will help maintain the needed student account balances.
