According to Public Act 101-0012 of 101st Illinois General Assembly, local school district e-learning programs, adopted by resolution, may not exceed the minimum number of emergency days in the approved school calendar and must be verified by the regional office of education or intermediate service center for the school district on or before Sept. 1 annually. Before adoption, the school board must hold a public hearing for initial proposal or renewal of e-learning program by:

The school board's approval of a district's initial e-learning program and renewal of the e-learning program shall be for a term of 3 years

Date of Public Hearing: Dec. 14,2021 Date of Board Meeting/Resolution: Dec. 14,2021

Specifically, the regional office of education or intermediate service center for the school district must verify that the e-learning proposal will: 1) ensure access for all students; ensure that the specific needs of all students are met, including special education students and English learners; ensure that all mandates are still met using the e-Learning program adopted; and 2) contain provisions designed to reasonably and practicably accomplish the following:

- Ensure and verify at least 5 clock hours of instruction or school work, as required under Section 10-19.05, for each student participating in an e-learning day
- Ensure access from home or other appropriate remote facility for all students participating, including computers, the Internet, and other forms of electronic communication that must be utilized in the proposed program
- Ensure that non-electronic materials are made available for students participating in the program who
 do not have access to the required technology or to participating teachers or students who are
 prevented from accessing the required technology
- Ensure appropriate learning opportunities for students with special needs Monitor and verify each student's electronic participation Address the extent to which student participation is within the student's control as to the time, pace, and means of learning
- Provide effective notice to students and their parents or guardians of the use of particular days for elearning
- · Provide staff and students with adequate training for e-learning days' participation

The entire 5 hours of instruction will be synchronous. Students will be provided instruction via Google Classroom. During the 1-hour Remote Learning, teachers will assign the students activities on an online platform that the student will do while logged into Google Classroom. This will also be time when teachers can conduct smalls groups. In the event that the teacher is out for day, a Sub (Ancillary Teacher) will take over the class. In the event that the teacher has connectivity issues, they will notify administration so that they can place another teacher in the class to provide supervision and instruction. Students that are English Learners will be provided the proper translations that support the lessons that the teachers will be providing. In addition, students that receive resource services will still receive them during eLearning Days.

Students with unique needs who cannot access technology will receive non-digital assignments. Those students who seem to be having difficulty may be given extra time to complete assignments or will be given extra help when they return.

Teachers will send out student assignments using grade-specific platforms (Google Meets and Google Classroom) and check to see that students have completed and submitted their assignments. Student who do not have access to the electronic platform will turn in assignments within one day of returning to inperson attendance or equal to the amount of eLearning Days utilized.

Our teachers will be available to assist students with their assignments during the hours of the regular school day. eLearning activities are designed to mirror activities used in daily classroom instruction. Assignments will focus on application activities where students can apply their understanding of concepts and use skills to solve problems.
