

MINUTES OF REGULAR MEETING OF THE BOARD OF EDUCATION OF

The Board of Education of Pinckneyville Community High School District #101, Perry County, Illinois, met in a regular session on the 23rd of August, 2021, at 6:30 p.m. at the Pinckneyville Community High School in that district.
