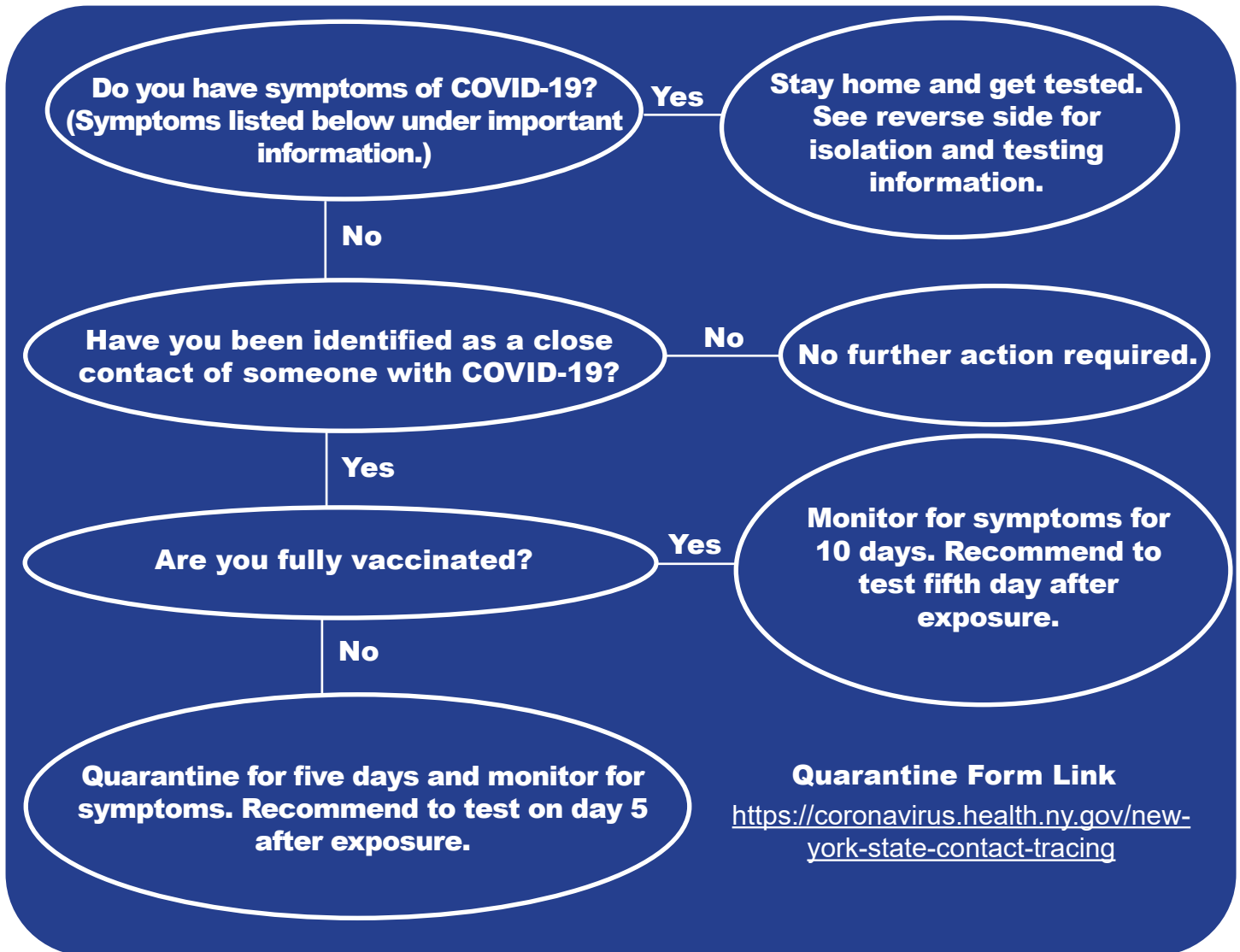


Updated COVID Protocols

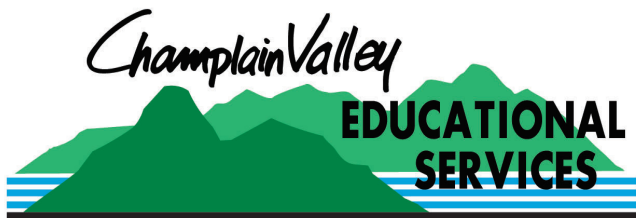

Important Information

— COVID-19 symptoms include: fever, chills, cough, loss of taste or smell, shortness of breath, fatigue, muscle or body aches, headache, sore throat, congestion or runny nose, nausea or vomiting, diarrhea, trouble breathing, chest pain, confusion or trouble waking up, bluish lips or face.



Updated COVID Protocols

Important Information

Please note, these policies and guidelines are ever evolving. Be sure to utilize the most recent information. COVID Guidelines are established by the CDC, the New York State Department of Health (NYSDOH) and our local health departments. The local health department makes final determinations regarding how these guidelines are implemented in each county. Additionally, schools must operate within the guidance of the New York State Education Department.

Isolation Policies

- Everyone who tests positive for COVID should stay home and isolate. Day 0 is the date of onset symptoms or date of a COVID test, and an individual is now eligible to be released from isolation after 5 days if symptoms are improving.
- For five days following isolation, you must wear a well-fitting mask around other people.
- If you are immunocompromised or unable to wear a well-fitting mask while around other people, you should continue to isolate for a full 10 days.
- Only return to work or school after day 5 if symptoms have improved and are fever free for 24 hours without the use of fever reducing medication.

Vaccination Status For Exposure

- **If you're fully vaccinated and got a booster shot at least two weeks before exposure:** You do not have to quarantine after a close contact with someone positive. Wear a well-fitting mask anytime you're around others for 10 days. If possible, get tested on day 5.
- **If you have your initial doses of the vaccine** (2 for Pfizer and Moderna and 1 for Johnson and Johnson) **and are eligible for a booster** (5 months away from your first dose of Pfizer (12 or older) or Moderna / 2 months away from Johnson and Johnson) **but have not yet received one:** You may ride the bus and attend school, wearing a well-fitting mask any time you are around others. For 5 days, you should quarantine when you are not at school, and you cannot participate in extracurricular activities.
- **If you are not vaccinated:** You should not attend school and should fully quarantine for five days and wear a well-fitting mask around others for five days after that. If possible, get tested on day 5. If you have access to an antigen kit, consider testing on day 2 or 3 and again on day 5.
