President Diane Wallick called the meeting to order with Directors Kirby Bierman, Heidi Shumaker, Randy Shumaker, Ray Vitense, Superintendent Jason Wester and secretary Jim Becker present. All board members were present in the building, however, due to the COVID-19 pandemic, this meeting was held online.

Motion by Kirby Bierman, seconded by Heidi Shumaker, that the May 11, 2020 meeting agenda be approved. Motion carried unanimously.

The Mission and Aim of the District were read.

The Pledge of Allegiance was recited.

Motion by Randy Shumaker, seconded by Ray Vitense, that minutes taken April 13, April 22, and April 29, 2020 be approved as reported. Motion carried unanimously.

Motion by Kirby Bierman, seconded by Ray Vitense, to approve a meal price increase of \$.10 for the 2020-21 school year. Motion carried unanimously.

Motion by Ray Vitense, seconded by Kirby Bierman, to combine the activity drama account and the activity thespian account. Motion carried unanimously.

Motion by Kirby Bierman, seconded by Heidi Shumaker, to approve the Software Unlimited invoice in the amount of \$6,350, the renewal of Dreambox in the amount of \$7,350, the Premier F&E proposal for elementary classroom furniture in the amount of \$11,969 and high school furniture in the amount of \$15,884, the Houghton Mifflin Harcourt K-8 English/Language Arts curriculum adoption in the amount of \$141,687.98 and the McGraw Hill high school geography curriculum adoption in the amount of \$8,621.70. Motion carried unanimously.
