All—

While we are all still decompressing from the school vote there is obviously a lot of interest in what comes next and moving forward, especially from families with kids in the schools who would like a resolution sooner rather than later. I am sure you are getting many of the same e-mails I am.

There are a lot of moving parts but one of them, obviously, is addressing the next SBC. There will be an article on the ATM warrant for a by-law governing future SBCs. I am hoping that we can reach some consensus both among the town's elected bodies and the "yes" and "no" folks on a general framework.

Below is what I have drafted that might provide a framework both for an by-law on the ATM warrant and an SBC to be appointed to get to work this winter before the by-law is adopted. There is no pride of authorship here, and I realize you cannot respond to the group given the OML. And I have not discussed this approach with Pete or Gus yet, but I am soliciting informal input at this point.

I would be pleased to have a telephone call or a cup of coffee with anyone to discuss. It likely will have to be after Thanksgiving as I am buckled down preparing for an argument in NYC on Tuesday.

For some reason I do not have Tim Knight's e-mail, so if someone could forward to him, I would appreciate it.

From a timing standpoint, I think it would be good to agree on a framework for how to appoint the SBC by mid-December, then give people a few weeks to apply, and the committee can be appointed in early January. As you probably know, Gus suggested a joint hearing with the School Committee and the BOS to take input on this.

As you probably know, Kristine and the financial team are working on how to fund the school building committee's work.

- > PROPOSED SCHOOL BUILDING COMMITTEE BY-LAW

- > Subject to the requirements of any applicable state statute or regulation,
- >
- > Any committee formed for the purpose of evaluating any potential new or renovated school building ("school building committee") will include at least 15 voting members, and will be appointed as follows:

- >
- > 5 by the Board of Selectmen, 5 by the School Committee, and 5 by the Town Moderator. Any committee members required by the MSBA or other rule or regulation of the Commonwealth by virtue of their positions to serve on such a committee will be appointed by the BOS and the School Committee as part of their minimum of 5 appointees. If the committee is to be expanded beyond 15 members, the size of the committee will be determined by the BOS and any additional members will be appointed by the Town Moderator.

- > The Council on Aging and the Warrant Committee may, in their discretion, nominate one or more people to serve on the School Building Committee. The BOS shall select as one of its 5 appointees from those nominated by the Council on Aging (if any), and the Moderator shall select as one of the Moderator's nominees at least one of the candidates nominated by the Warrant Committee (if any).

- > The BOS may appoint any additional non-voting members in its discretion or to comply with any state statute or regulation.
