The meeting was called to order for open session by Heber Loughmiller, Vice-Chairman of the Board.

EXECUTIVE SESSION: Motion by Darin Moon and seconded by Jeff Rasmussen to go into Executive Session in accordance with Idaho Code § 74-206(1)(b) (b) To consider the evaluation, dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, or individual staff member or individual agent, or public school student. And, in accordance with District Policy 541, Prohibition of Weapons. Voting Aye: Rasmussen, Thompson, Moon, Loughmiller; motion carried.

OPEN SESSION: Motion by Darin Moon and seconded by Bruce Thompson to go into Open Session. Voting Aye: Rasmussen, Thompson, Moon, Loughmiller; motion carried.

ACTION ITEM(S): Motion by Jeff Rasmussen and seconded by Darin Moon to approve the expulsion of Student 2018A from all schools belonging to the Cassia County Joint School District No. 151 for a period of 365 days beginning November 30, 2018, ending on November 30, 2019 per Idaho Code §33-205, “Denial of School Attendance” from the Idaho Codebook and District Policy 541, “Prohibition of Weapons”, then suspending the expulsion on the date of Monday, January 07, 2019 if Student 2018A registers at Cassia Jr/Sr. High School and attends school for the remainder of the 2018-2019 school year. Voting Aye: Rasmussen, Thompson, Moon, Loughmiller; motion carried.

During the period of enrollment at Cassia Jr/Sr. High School Student 2018A will be placed on a one-major-offense contract. Student 2018A may be required to attend summer school which is dependent upon Student 2018A’s grades. At the end of the 2018-2019 school year cooperating administrations from the regular high school and Cassia Jr/Sr. High School will deliberate, review attendance, grades and behavior with the purpose of determining possible enrollment at the regular high school for the school year 2019-2020. In the event that there is a major student conduct offense at Cassia Jr/Sr. High School,

the expulsion exception will be terminated and attendance within Cassia County Joint School District No. 151 will be denied through November 30, 2019.

It was noted that the Board of Trustees wished Student 2018A well and encouraged Student 2018A to keep on track with school studies.
