The meeting was called to order by Board President Carney.

Moved by Dinkla and seconded by Leonard to approve the agenda with the addition of discussion of Weight Room reopening. Motion carried 5/0.

Guest present was Dave Farley. No one spoke during the community communication time.

The minutes of the December meeting, claims for payment, open enrollment applications and financial reports were discussed. Moved by Kading and seconded by Dinkla to approve the consent agenda items. Motion carried 5/0.

Preliminary whole grade share billings from Guthrie Center to Adair Casey as of 12/31/2020 were distributed. Bills should be reviewed and will be on the February agenda for approval. The percentage split is Adair-Casey 37.87% and Guthrie Center 62.13%.

The return to learn plan was reviewed. Mr. McClain recommends no changes currently. The COVID vaccine will be available to staff sometime after February 1st. Distribution will most likely be on a Friday for those wishing to receive it.

Moved by Kading and seconded by Dinkla to accept the bid of \$400 from Randy Huss for the used school bus. Motion Carried 5/0.

Moved by Kading and seconded by Leonard to adopt the changes to Board Policy as recommended by IASB in Policy Primers; Vol. 28, Number 3 and Vol. 29, Number 3. Motion carried 5/0.

Moved by Kading and seconded by Dinkla to approve to continue the funding to Kid Zone in the way of utility bills. Motion carried 5/0.

Moved by Kading and seconded by Dinkla to approve the reopening of the weight room to community members with limited hours beginning February 1, 2021. Motion carried 5/0.
