Moved by Dinkla and seconded by Kading that school fees remain the same for the 2019-2020 year. Motion carried 5/0.

Moved by Kading and seconded by Leonard to accept the resignations from Tara Hyett as Kindergarten teacher and Mark McDermott (under Guthrie Center contract) as JH Math and Social Studies teacher. Motion carried 5/0.

Moved by Dinkla and seconded by Leonard to approve the hiring of Cindy Lundy as Elementary Secretary, Stacey Young as Kindergarten teacher and Andrew Treiber as JH Math and Social Studies teacher. Motion carried 5/0.

Moved by Dinkla and seconded by Leonard to approve the issuance of the Teacher Leader contracts. Motion carried 5/0.
