President Monica Walker called the Board Meeting to order at 6:07 pm with a quorum established.

Director Jeromie Allen made the motion to approve the agenda. Seconded by Director James Fowler. Motion carried 6-0.

Director Tara Adkins made the motion to approve the consent agenda (approval of the minutes & authorization of the payment of bills {Director Adkins}) Seconded by Director Jeromie Allen. Motion carried 6-0.

Old Business:

Director Jeromie Allen made the motion to approve the 2022-2023 school calendar as presented in the board packet. Seconded by Director Tara Adkins. Motion carried 6-0.

Director Tara Adkins made the motion to approve steps and a \$700 increase to the base for certified staff and a 3.134% raise for non-certified staff (Option 3 of the proposed salary scenarios presented to the board)for the 2022-2023 school year. Custodial staff will receive a \$1.00/hr raise to keep on track to meet the state minimum wage requirement. Seconded by Director James Fowler. Motion carried 7-0.

Director Jeromie Allen made the motion to approve Option 3 of the Paraprofessional/Custodial Salary Schedules as presented in the board packet. The schedules are newly created and reflect the salary increases for the 2022-2023 school year as voted on in the previous vote. These schedules will provide a consistent way of determining a starting wage for a new employee in the district. Seconded by Director Victor Orta. Motion carried 7-0.

New Business:

Director Victor Orta made the motion to approve Michelle Jacobs as a 1:1 student aide for the remainder of the 2021-2022 school year. Seconded by Director Jeromie Allen. Motion carried 5-0-2.

Director Tara Adkins made the motion to add Kelsey Roe, Hannah Perks, and Sarabeth Michael to the 2021-2022 substitute teacher list. Seconded by Director Bobbie Jo DeShon. Motion carried 7-0.

Director Victor Orta made the motion to add Emily Jacobs to the 2021-2022 substitute teacher list. Seconded by Director Jeromie Allen. Motion carried 5-0-2.

DeKalb County SRO Supervisor Wayne Morris shared information with the Board regarding building security. He gave a brief presentation on the School Guard Program and answered questions the Board had after viewing a video.
