New hires with experience may receive up to five (5) years experience (12 months work equals one year of experience. In accordance with the applicable job description advancement to ME 2 or ME 3 shall be only on the recommendation of the trasportation supervisor and approval of the superintendent. Advancement will be based on the combination of performance, experience and certification/education.

The regular work week shall consist of 40 hours per week as set by the transportation supervisor.
