2023/2024 Meal Program

We are pleased to inform you that Mannheim School District 83 will participate in the Community Eligibility Option (CEP) program offered by the United States Department of Agriculture for the 2023/2024 school year. This program allows us to provide a breakfast and lunch for our enrolled students **at no cost** to families.

Parents or Guardians are not required to apply or provide documentation for free or reduced breakfast and lunch. Parents or Guardians do however need to complete a Household Income Eligibility Form along with proper documentation to determine qualification for a Waiver of the Registration Fee.

USDA guidelines stipulate that students must select three (3) out of five (5) healthy food components at each meal – one of which must be a fruit or vegetable – for a healthy, balanced breakfast and /or lunch. Also, students are not allowed to take milk alone. Milk must be combined with a fruit or vegetable and one other component to total 3 items.

Breakfast (After the Bell) / Lunch

All students in Kindergarten through 8th grades will be provided a nutritious **breakfast** as they enter the classroom after the first bell and the school day begins.

Lunch will be served at scheduled times in the cafeteria.

Ala Carte options are available at Mannheim Middle School 6th - 8th grade students (only), during all lunch periods in the cafeteria.
