RESOLUTION # 319 - 11/4 Approve Resolution Authorizing the purchase and lease of real property.

It was moved by Mr. Gibson and seconded by Ms. Carter to approve the resolution Authorizing the purchase and Lease of real property.

Mr. Gibson introduced the following resolution and moved its passage:

RESOLUTION NO. 319

AUTHORIZING THE PURCHASE AND

LEASE OF REAL PROPERTY

(Ohio Revised Code §3313.17)

WHEREAS, Rita M. Worley, Donald R. Conner and Margie I. Conner (collectively, the "Sellers") are the owners of Hamilton County tax parcel number 641-0011-0098-00, consisting of approximately 0.196 acres, together with all improvements and fixtures presently located at 220 North Cooper Avenue, Cincinnati, Hamilton County, Ohio (the "Property"); and

WHEREAS, the Board of Education (the "Board") of the Lockland Local School District wishes to purchase the Property for school purposes and Sellers desire to sell the Property to the Board;

WHEREAS, upon purchase of the Property, the Board desires to lease the Property described above to the Sellers for a term of approximately six (6) months;

WHEREAS, pursuant to section 3313.17 of the Ohio Revised Code, the Board is authorized to both acquire the Property from Seller and lease the Property back to Seller; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Lockland Local School District as follows:

- 1. It is found and determined by the Board that the Property is needed for school purposes.
- 2. The Board hereby authorizes the Superintendent and Treasurer to negotiate with Sellers for the purchase of the Property upon terms substantially similar to the Real Estate Purchase Contract (the "Contract") attached hereto as Schedule 1 for the purchase price of One Hundred Eighty Thousand and No/100 Dollars (\$180,000.00). The Board does not need to review the Contract again unless there is a material change to the Contract.
- 3. The Board hereby further authorizes the Superintendent and Treasurer to negotiate with Sellers for the lease of the Property upon terms substantially similar to the Lease Agreement (the "Lease") attached hereto as Schedule 2. The Board does not need to review the Lease again unless there is a material change to the Lease.
- 4. The Board hereby further authorizes the Superintendent, Treasurer and/or Board President to execute such Contract and Lease and any and all other documents required to be executed or reasonably necessary in connection with the Board's performance under the Contract and Lease and the closing of the transaction contemplated thereunder.
- 5. Any prior actions taken consistent with this resolution are hereby ratified, affirmed, and approved.
- 6. The Superintendent, Treasurer and/or Board President are hereby authorized and directed to do all things necessary and consistent with this resolution to accomplish the acquisition and lease of the Property including paying reasonable costs incurred in connection therewith. The Superintendent, Treasurer and/or President further are hereby authorized and directed to agree to any other terms that are not materially inconsistent with the conditions set forth in this Resolution.
