Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2020-21 educational progress for Tyler Elementary School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2020-21 school year, schools were identified using new definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has three or more underperforming student subgroups. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school has not been given one of these labels.

One of our key challenges is ensuring that students who have been identified in the bottom 30% in each content area on the M-STEP meet proficiency targets set by the state of Michigan. To meet the needs of these students, we continue to analyze our data and provide appropriate interventions for these students; including targeted reading and mathematics instruction from the classroom teacher as well as the interventionist.

State law requires that we also report additional information.

- 1. Our process for assigning pupils to Tyler Elementary is based on residency and the boundaries of the district.
- 2. A major focus of the school improvement plan is increasing student achievement in all content areas; especially in the area of mathematics and literacy. A driving force for our school improvement plan is using data from NWEA, Common Unit assessments and DRA scores. This data is analyzed monthly to assist us in providing differentiated instruction and meet our school improvement goals. Staff development is an integral component of the ongoing school improvement process.
- 3. Some of Tyler's Points of Pride include: Leader in Me School, New Tech Elementary, 90-minute Literacy blocks, 60-minute math blocks, after school tutoring, Educational Assemblies and Field Trips, Hands-On Science Investigations, Integrated Technology, Reading Specialists, School-Wide Title I services, Professional Learning Teams, Art, Music, PE and Media Instruction.
- 4. The school follows the state curriculum of the Michigan Common Core State Standards.
- 5. For the 2020-2021 school year we have included the percentage of students who met or exceeded proficiency on the NWEA assessment for the September testing period.
