

Occupational Therapy Agreement

AGREEMENT

This agreement made and entered on 8/22/16 between Another Choice Virtual Charter School (purchasing agent) and OT On the GO (contractor) for the school year 2016-2017.

PURPOSE OF AGREEMENT

To provide Occupational Therapy services for eligible children as referred by the purchasing agent.

CONTRACT PERIOD

This agreement shall commence on 8/22/16 and shall continue as an ongoing agreement unless terminated by either party upon thirty days of written notice by one party or the other.

COMPENSATION

Contractor shall provide Occupational Therapy serviced as indicated under Purchase for the sum of: \$65.00 per hour on an as needed basis as long as funds are available. Travel will be reimbursed at \$32.50 per hour for the Contractor to travel to Nampa from the Boise area and to any home or location as requested by the school staff. There will be a minimum one hour fee for each visit.

TERMS OF CONTRACT

The purchasing agency will:

- A. Pay bill for services provided upon receipt of invoice.
- B. Notify contractor when updates on client progress are required for specific staffings, meetings, or IEPs.
- C. All referrals for services will receive prior authorization by Another Choice Charter School Special Education Director.

The contractor agrees to the following terms:

- A. Contractor will provide Occupational Therapy on a Direct Service basis which may include, but is not limited to:
 1. Evaluation and assessment.
 2. Direct treatment.
- B. Contractor will provide Occupational Therapy on an Indirect Service basis via monitoring and consultation which may include, but is not limited to:
 1. Assessment and evaluation.
 2. Consultation to teachers, aides, parents, and other school professionals.
 3. Documentation of #1, and #2 as well as specific therapy programs.
 4. Monitoring students' progress by observation, discussion with teacher/aides, and applying hands-on assessment and treatment, as needed.
- C. Contractor will bill Purchasing Agency by time sheet.
- D. Contractor will provide services at the school which the child regularly attends or other predetermined site.

RESPONSIBILITIES

The purchasing agency will provide:

- A. Space for evaluation and treatment.
- B. Equipment and testing materials not provided by contractor.

The contractor will:

- A. Provide services as outlined in Terms of Contract.
- B. Provide documentation of assessment, evaluation, and progress as required by the school district.

This agreement may be amended or modified mutual written agreement of the participating parties.
