According to the Arkansas State Academic Standards, the Lake Hamilton collaborative teacher teams have identified essential standards for each content area. All students will have the opportunity to learn the grade and subject academic standards in the following settings:

<u>On-site learning</u>, the majority of students will receive instruction in a face-to-face setting.

<u>Virtual learning</u> virtual option will be limited to students who have a medical need for off-site learning.

Virtual learning is offered to 9, k-6 students through the Dawson Educational Cooperative Digital Learning Program. Virtual Arkansas will provide virtual learning to 11 of our 7th-12th students.

The district is one to one with digital devices. Kindergarten students will have iPad access, and 1st- 12th-grade students will have Chromebook access.

Diagnostic testing used to identify learning gaps from grades k-2 is Istation, and for grades 3-8 is NWEA. The PRE-ACT assessment will also be used in grade 9.

Junior High and High School will implement the RtI Scheduler in order to provide Tier 2 and Tier 3 supports for students in need of remediation.

Utilization of LMS- k-5th grade will use Seesaw as a management system. The 6th-12th grade will use Canvas as a learning management system.

Social, Emotional, and Mental Health support will be led by a team of building counselors, social workers, and mental health professionals. These professionals will provide individual, small group, and family counseling services.

Each school is implementing the Guide for Life curriculum through building counselors.

The district provides students and families with physical support through the Parent Center. The center will provide families in need of food, clothing, and community resources.

The district liaison will support students and families who may need assistance due to homelessness, foster care, and military family support.

Communications with students, families, and the community will be provided through the district's communication coordinator, district translator/interpreter, and building-level communications representatives.
