LDD Federal Government-Drug Free Schools
(See GAOA, GAOB, IDAB and JDDA)

LDD

The unlawful possession, use, sale or distribution of illicit drugs and the possession, use, sale, or distribution of alcohol by students or school employees at school, on or in school property, or at school sponsored activities or events is prohibited. This policy, and any curriculum used in conjunction with it, shall be evaluated periodically using criteria developed by the superintendent and approved by the board. The board shall receive a report after each of these reviews is conducted.

It is the policy of the board not to hold school activities in the district on Wednesday nights after 6:30 p.m. or on Sundays. Additionally, it is the policy of the board not to open the buildings for use on Sundays prior to 12:00 noon for any reasons other than a civic emergency.

For the purposes of this policy, “school activities” are those events that are conducted by the school district and are placed on the school district calendar. By way of example, “school activities” include, but are not limited to practice and/or competition in sports, drama, music or other school events where attendance of participants is required. Also by way of example, “school activities” do not include voluntary participation in open gym, game film review, individual practice in track or field, or work for classes when the equipment necessary for the work (darkroom, computers, etc.) is located in the school.

This policy shall not apply to the following situations:

- Items which are not defined as “school activities” under the above definition.
- Travel to an activity when the activity is scheduled by an outside organization and is scheduled at such a time as to make travel necessary on Wednesday evening or on Sunday as determined by the building principal.
- Participation in KSHSAA scheduled competition.
- Meetings which are generally of an ‘adult’ nature such as board of education meetings, site council meetings, staff inservice, employee-employer negotiations.
- Individual or coincidental meetings between staff and students.
- Student attendance at events of an ‘adult’ nature held on school property when those events are not hosted by the school district. Examples include attendance at community college night classes, participation in community activities such as Men’s Basketball, or City Volleyball.
- Activities or events which are listed on the calendar and approved by the board when the calendar is adopted at the regular February meeting.
- Activities or events which are approved by the board which otherwise may require deviation from this policy.

Activities which cannot be determined by the principal or, in turn, the superintendent under the guidance provided by this regulation may be brought before the board for

consideration at any regular or special meeting of the board. Any such request shall be accompanied with a recommendation by the administration.

October 6, 1997 *[It is the intent of this policy that the times included herein should usually apply to the general public as well as the school district, especially in any case where students may be involved in the proposed activity. Further, it is the intent of this policy that these times are for family activity choice and for nothing that can be construed as school-related. As clarified in the previous paragraph, any questions or issues that arise should be brought to the board of education for consideration well in advance of the requested event.]*
