ESSER II -

Federal emergency funds that were given to a State or Local Educational Agency in response to the COVID-19 pandemic.

- Can be used for a wide range of activities to address the needs of individual school districts arising from or exacerbated by the COVID19 pandemic
- Allocating resources due to disproportionate impact of COVID19 on subgroups



ESSER III

Federal emergency funds that were given to a State or Local Educational Agency in response to the COVID-19 pandemic

- Requires that districts spend at least 20% on learning loss
- The balance can be used on the same items as CARES Act Grant:
 - Supplies to sanitize/clean buildings.
 - Repair and improve school facilities to reduce the risk of COVID transmission and improve indoor air quality
 - Address the needs of Students with Disabilities (SWD's), low-income families, English Language Learners (ELLs), and racial/ethnic minority students.
 - Academic opportunities to address learning loss

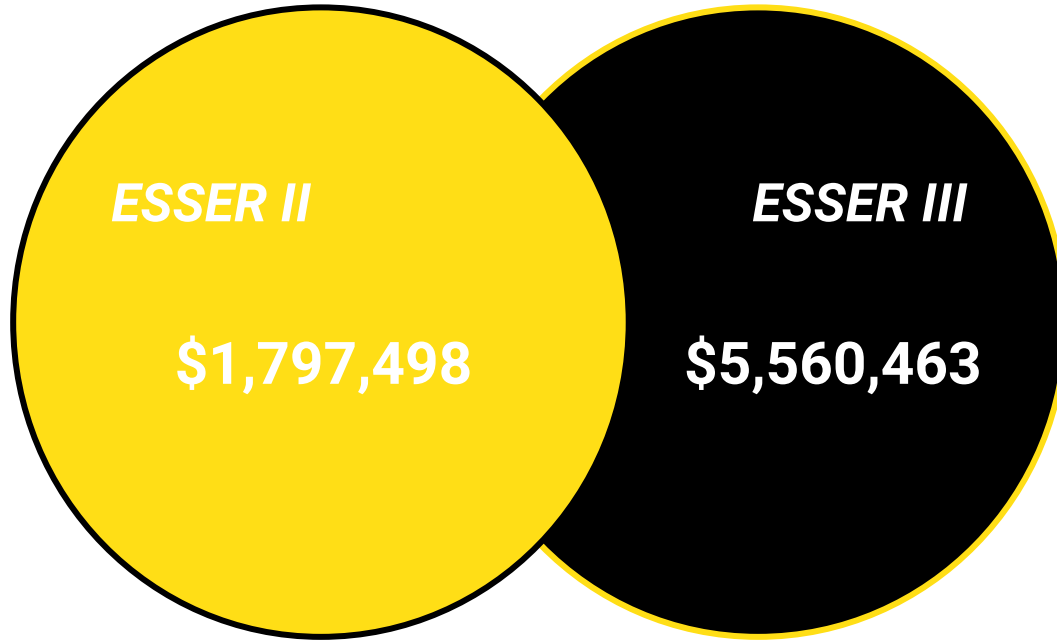


ESSER III requirements:

- District 50 must seek public comment when developing its Safe Return to In-Person Instruction and Continuity of Services (Safe Return to School) plan
- District 50 must create an ESSER Use of Funds Plan within 90 days of receiving its allocation. This plan must also be made available on the District 50 website when the grant is submitted to ISBE

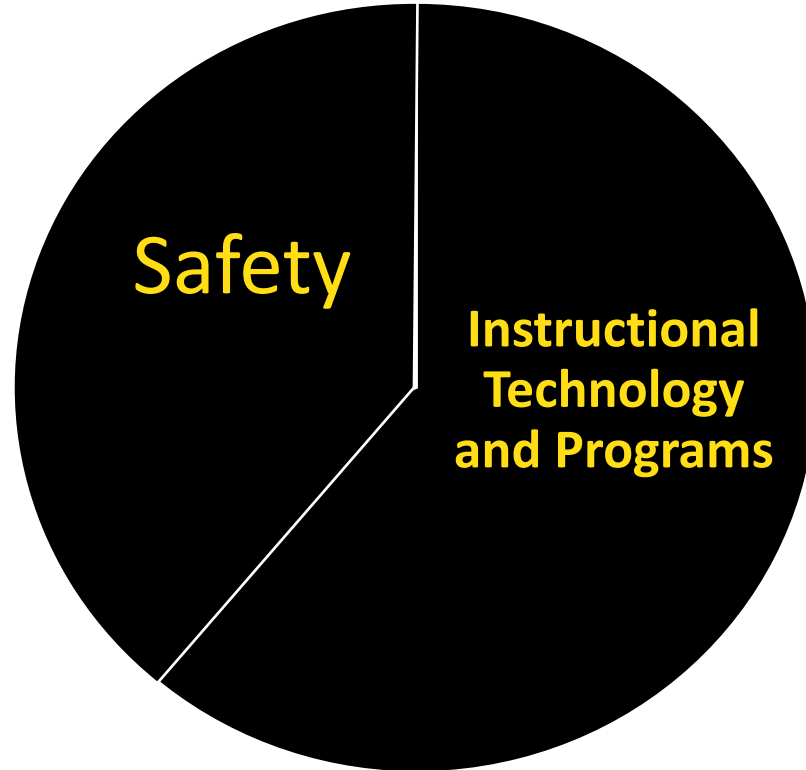
