There are approximately 204 certified staff members and 199 non-certified employees.

What happens after I submit a request?

The Illinois Freedom of Information Act requires agencies to respond to requests for non-commercial purposes within five business days after the District's receipt of the written request. The Act provides, however, that under certain circumstances, the response time may be extended for up to five additional working days. If this happens, you will be notified by letter specifying the reason for the delay. The requester and the District also may agree in writing to extend the time for compliance for a period of their choosing.

The FOIA Officer shall respond to written requests for <u>commercial</u> purposes within 21 business days after receipt. If a request is for a commercial purpose, the requester must disclose this.

What is the fee for duplication of public records?

The first 50 pages of black and white, letter or legal-sized copies are free. Additional pages are 15 cents per page. The District may not charge more than the actual cost for reproducing color copies or copies of other sizes.

What other fees might apply?

Costs related to personnel for searching, retrieval, redacting, will be charged at a rate of \$10.00 per hour above the first 8 hours of labor.

What happens if my request is denied?

You will be informed in writing if your request is denied and the reason for the denial. You have the right to have the denial reviewed by the Public Access Counselor (PAC). They can be contacted at:



Good evening---the judge has just ruled in the Austin case and has struck down the governor's authority regarding COVID 19 mitigations. This is a bit complicated due to the earlier order in the day not granting class action status. We'll review with our attorneys ASAP. I'll keep you updated as this unfolds.

In the meantime, I'm going to be sending this email to parents and staff:

A short time ago, an Illinois judge ruled on a lawsuit filed by more than 700 parents across the state that challenged the current state-mandated COVID-19 mitigations.

I write to let you know that we are aware of the decision and reviewing the implications for our school district. Thank you for your patience and understanding as our district navigates the latest changes to the COVID-19 guidance and rules for Illinois schools.

At this time, we are in the process of reviewing the judge's decision and will communicate with you as soon as possible whether and how this ruling impacts Mahomet-Seymour students and staff members.

Good afternoon Superintendents and Board Members,

I'm contacting you today at Senator Rose's request to address an issue that has been raised by several elected officeholders from around our district with questions and concerns related to changes in the Statement of Economic Interest (SOEI) that elected officials are required to complete in Illinois. In some cases, the new SOEI forms have been distributed without a complete listing of the exclusions, which has caused some confusion around the district.

From Senator Rose:

"While, we cannot provide legal advice, the attached memo has a nice summary of what is statutorily excluded (and I think will relieve a lot of the stress). Also, the excel chart attached – shows how the previous SOEI statutory questions were consolidated to make them easier to understand (assuming, of course, that someone had also sent the context of the "exclusions" up front and you didn't get one without the other)! Importantly, it also raised many of the limits and we got rid of many of the reporting requirements like retirement accounts, for example (these were previously required to be reported, and are now, under the new law, no longer reportable).

What is new is (i) the "debt" question (but again, looking at the exclusions to determine what is not reportable is very important) ... the inclusion of this question was to make sure that people weren't getting off-market "loans" from people seeking business with the unit of government they are elected to, and (ii) the question of utility companies, which I will admit has really very little applicability to local governments – but could.

Again, we can't give legal advice, but I'd suggest you reach out to your school attorney, or local State's Attorney, if you have questions of interpretations on what is/isn't reportable."
