Motion made by Director Sterner and supported by Director Fairchild to accept the resignations of Kriste Elmore-School Nurse, Rebecca Rozenboom-Elementary Associate/Driver/Summer Mowing, Lauren Gangel-Speech Coach effective immediately; and the hiring of Stephanie Hays as Speech Coach effective immediately.
