

**SANFORD SCHOOL DEPARTMENT**  
**SCHOOL FACILITY**  
**NAMING RIGHTS AGREEMENT**

This School Facility Naming Rights Agreement is entered into between the Sanford School Department and Weirs Collision Center.

In consideration of Twenty-Five Thousand (\$25,000.00) pledged to the Sanford Schools Legacy Foundation, the Sanford School Committee grants Weirs Collision Center the naming rights to the Automotive Collision Repair Career and Technical Center Lab. This does not preclude the Sanford School Department or Sanford Schools Legacy Foundation from partnering with other organizations to raise funds for the same facility.

1. Purpose. The parties enter into this Agreement for the purpose of generation of revenue for Sanford Regional Technical Center as consideration for a promotional opportunity for the Sponsor.
2. Authority. The parties enter into this Agreement pursuant to Sanford School Department policies KK and KCD.
3. Facility. The parties agree that the Automotive Collision Repair CTE Lab shall be referred to in publications and communications by the Sanford School Department by the name “Weirs Collision Center” during the term of this Agreement.
4. Term. This Agreement shall commence on January 1, 2022.
5. Payment. On or before January 31, 2022, the Sponsor shall remit \$25,000.00 to the Sanford Schools Legacy Foundation. Failure of the Sponsor to timely remit the payments provided in this paragraph shall render this Agreement void without further action of the parties.
6. Transferability. Naming rights are not transferable, whether “Weirs Collision Center” ceases to exist through merger, acquisition or bankruptcy.
7. Renewability. The parties may enter into an extension of the naming rights as may be mutually agreed upon sixty (60) days prior to the expiration period. If a subsequent term is not negotiated, the Naming Right may be resold to another entity and all reference to “Weirs Collision Center” would be null and void.
8. Notice. Written notice to either party under this Agreement shall be submitted to the following:
