- Parent photo ID with current district address

#### REGISTRATION PROCEDURES FOR NEW DISTRICT RESIDENTS AND ADDRESS CHANGES WITHIN THE DISTRICT

If you are a <u>new</u> resident in the district or move within the district, you must also <u>register in person</u> at the Registration/Transportation Office and have the following documents:

- The Original Birth Certificate of the child/children that are to be registered (new residents only)
- Proof of Residency: Deed, Tax Bill or Closing Statement. If you rent, whether you have a lease or not, you will be given two affidavits that must be completed, signed and notarized (same as above)
- Proof of parental relationship
- Parent photo ID with current district address
- Postal Change of Address
- Plus one item listed below\*
