**Mutual Agreement Between the Parties  
College Technician Program**

Upon being selected, TCI will purchase up to five thousand dollars (\$5,000) worth of hand tools for the selected future technician. Said tool receipts are required to be submitted at the time the technician requests reimbursement. An inventory of said tools will be made a part of this agreement.

Said tools are the property of Town and Country Implement until the technician has been a full-time employee of Town and Country Implement for five years (60 months) after graduation. If technician leaves employment prior to the five year (60 month) requirement, technician is required to return all tools. After the five year (60 month) requirement, said tools become the property of the technician.

Town and Country Implement will pay up to fifteen thousand dollars (\$15,000.00) in the form of tuition, books, room and board. Copies of said tuition expense, books, room and board are required to be submitted at the time technician requires reimbursement. Said reimbursement will be paid to technician in the form of (36) equal monthly payments, provided technician remains employed at Town and Country Implement. If technician leaves employment prior to the thirty-six (36) month requirement, monthly reimbursement will cease.
