

Council Meeting

The Graettinger City Council met in regular session Monday, June 12, 2023, at 6:00 P.M. with Mayor Flaherty presiding. Present were council member Armstrong, Masters, McGrauth, Alderson and Dyhrkopp. Present were city employees Henderson, Currans, Peterson, and Anderson. Visitors: Gina Hall, Marleen Kitto, and Jaren Nissen.

Motion by McGrauth, seconded by Armstrong to approve consent agenda. 1. Motion to approve agenda. 2 Motion to approve minutes. 3. Motion to approve bill. 4. Motion to approve financial statement. 5. Motion to approve liquor license for Graettinger Veterans Club. 6. Motion to approve Liquor Licenses for Lodge on Main and Sunday license. 7. Motion to approve liquor license for Side Street Saloon, Outdoor and Sunday license. 7. Motion to approve Cigarette License for Graettinger Country Store, Graettinger Market and Dollar General All ayes. Carried.

Two bids were acquired for furnace and air conditioning system, Bauer Plumbing and Heating and Currans Plumbing and Heating. Motion by Alderson to accept Currans Plumbing and Heating at the lower quoted bid. Seconded by McGrauth. All Ayes. Carried.

Peterson and Anderson advised the council they would like Smith to be able to cover call hours and some other duties. Council in agreement Smith can cover additional duties while Harris out. Smith will maintain his part time status.

Motion by Masters to pay to accept quote from Blacktop Services for street repair. Seconded by Armstrong. All ayes. Motion carried.

Motion by Dyhrkopp, seconded by Alderson to give a 7% raise to city employees. All ayes. Carried.
