a. P1 GROUP:

P1 Group is willing to come back to the next board meeting if there is interest in any in the proposals of the investment grade audit. Mike Mathes said that most of the proposed improvements can be done with Capital Outlay money, which would save the district a lot of money compared to a lease purchase. He would like to work on a Capital Outlay improvement plan which will include how, going forward, Capital Outlay dollars should be spent. His recommendation is to spend approximately \$1 million a year on improvements and/or upgrades. Mr. Mathes recommends to the Board not to move forward with P1 Group. The Board would like to put a brake on the plans with P1 Group.
