PURPOSE:

Under the general direction of the Superintendent, the Technology Resource Specialist ensures implementation and maintenance of major technology initiatives District-wide, including: the design, installation, repair and maintenance of networked computer systems and server connection to the internet; the training of, and assistance to, teachers, administration, support staff and students in the use of District-approved networked hardware and software; the reliability, security and maintenance of local area network cabling and wireless connectivity; and evaluating software and hardware needs throughout the district including making recommendations to site principals and other administrators regarding design, acquisition and installation of system upgrades and initiatives. Incumbents in this classification provide students, staff and the public with reliably functioning instructional and administrative/school business-related technology which directly supports student learning.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

(Note: These examples are intended only as illustrations of the various types of work performed in positions allocated to this class. The examples of work performed are neither restricted to nor all-encompassing of the duties to be performed under this job title.)

- Provides technical assistance to the District by serving as technology resource including providing technology workshops, staff training in use of technology tools, and one-on-one help.
- Provides district-wide and site-specific help desk service to troubleshoot technology hardware and software issues.
- Installs, configures and maintains computer operating systems using appropriate imaging systems and procedures.

- Installs, configures and troubleshoots hardware and software issues on District equipment.
- Maintains, adjusts, upgrades and repairs district technology hardware and software.
- Maintains updated knowledge of all aspects relating to wide area and local area networks.
- Resolves and manages network connectivity problems.
- Manages the planning, installation and maintenance of security cameras.
- Manages E-rate process and submission of required information to appropriate entities to maintain eligibility for E-rate subsidies.
- Optimizes network at different school sites including VLAN management, subnet planning, switch and router management.
- Troubleshoots issues related to all District computer and data communication equipment.
- Maintains, services or makes recommendations regarding the maintenance/repair of computers, laptops, tablets and peripheral equipment including printers, projection devices, and interactive devices.
- Maintains accurate service and inventory records of servers, computers, laptops, tablets and peripheral equipment including printers, projection devices, and interactive devices; report updates monthly to the designated District administrators.
- Maintains accurate and up-to-date inventories of digital devices, computers, servers, and all other network equipment (wired and wireless) throughout the District.
- Communicates with vendors for support and repair of District computer equipment.
- Recommends, maintains and monitors security policies for users and groups.
- Monitor and manage Google Apps through admin portal and user management using GAM.
- Provides support for data management on the following systems: Synergy, SEIS and CALPADS
 as well as downloading or interfacing with student/parent information to other communication
 systems such as Blackboard Connect Ed or the Parent Online payment system. Researching and
 evaluating computer network software and hardware for use in local area networks (LAN).
- Communicates through District email service and other electronic communications.
- Performs other duties related to the class as assigned.
