Let Local—Stay Local

Many, not all, legislators under the dome in Topeka are trying to strip away local control of the board of education in public schools across Kansas. Over the course of the past several years, and especially this year, many bills have been proposed which identify signs that many of the current law makers in Kansas are not in favor of public education. These signs have come in the form of decreasing funding to public education, not funding special education as required by law, and by developing bills which limit and remove local board of education decisions.

As parents and patrons of USD 330 Mission Valley and of residents of Kansas, you already have the right to know and request information about what is being taught in public schools, what rights you have as a parent, etc... Speaking as a person who has been in public education for over 25+ years, at no point have I heard of a parent being denied access to what their child(ren) is being taught in public schools. House Bill 2662 and substitute bills created from it, establishes what is being called the Parent's Bill of Rights and Academic Transparency Act. This act is a ruse to promote the thought that parents are not being informed about what their children are being taught, when in fact, parents already have the right to know about what curriculum their child(ren) are being taught. One extreme downfall of this bill is that it wishes to require that every bit of information, resources, etc... that is used in the school be made readily available through parent transparency portals prior to the start of a school year or semester. Not only would this take an enormous amount of time to put together for an entire district but it also takes away from the flexibility of our educational professionals, it places barriers on their instruction by not allowing them to use "teachable moments". A teachable moment is something that just sometimes occurs in the classroom when it is not expected, it is a moment that is grasped by the teacher to have a discussion or lesson about a real life situation. In essence, HB 2662 is a mechanism for educational opponents to generate mistrust of content being shared between public school and parents/patrons.

Two other bills which remove local control by the elected board of education include HB2511 and HB 2553. House Bill 2511 which includes the eligibility of "home schooled" students in KSHSAA Activities, while HB 2553 includes allowing students to transfer to and attend school in any school district in the state. Again, both of these bills remove local control by the elected local school boards. Currently, school boards may allow students who receive their education in a homeschool setting the opportunity to participate in KSHSAA activities, so long as the students meet KSHSAA requirements. There is not a law that says they are automatically ineligible, but rather, only if decided upon by the local board of education. HB 2553 is in regards to allowing students to transfer to and attend school in any school district in the state. This bill also requires school districts to set transfer capacity and adopt certain transfer policies, as well as establishing an appeals process if a transfer request is denied. Again, school districts can already decide if they choose to allow out-of-district students so what is the purpose of this bill other than to remove control that already exists for local school boards. USD 330 Mission Valley already has a process in place for students/families who wish to attend school at Mission Valley but do not reside in the district. It is understood and followed by our public school district that denial of out-of-district attendance can not occur because of ethnicity, national origin, gender, income level, disabling condition, English proficiency, measure of achievement, aptitude or athletic ability, religion, etc... Public schools are just that......schools for anyone who resides in the district no matter of race, ethnicity, ability level, religion, etc... By requiring public school districts, who are led by board members voted in by the public, to accept out-of-district students......then who is making decisions on local control? Is it the board members elected at the local level........ o

Unofficial Minutes (subject to Board approval) REGULAR BOARD OF EDUCATION MEETING – February 14, 2022

Board President, Jacob Durkes, called the regular meeting of the Board of Education of Mission Valley USD #330 to order at 7:01 p.m. in the Elementary Cafeteria at Mission Valley Schools. Board members present were Jon Deters, Chris Campbell, Nick Beasterfeld, Tuff Stephenson and Mistina Kraus. Clipper Goodrich was absent. The superintendent and deputy board clerk also attended.

Tuff Stephenson moved, seconded by Jon Deters, to adopt the agenda with the following change; VII. Action. F. Estimates for Upgraded Roof Material moved to VII. Action. A. Motion passed 6 to 0.

Tuff Stephenson moved, seconded by Chris Campbell, to approve the consent agenda as presented. Motion failed 0 to 6, with Jacob Durkes, Mistina Kraus, Tuff Stephenson, Jon Deters, Chris Campbell and Nick Beasterfeld voting no.

Tuff Stephenson moved, seconded by Jon Deters, to approve the consent agenda with the following change; remove the hiring personnel form for high school assistant softball coach in order to advertise the position. Motion passed 6 to 0.

Items in the consent agenda that were approved include: approval of minutes from the January 10, 2022 regular board meeting; approval of clerk's report and treasurer's report as presented; approval of warrants in the amount of \$232,095.51; approval of extra duty pay in the amount of \$4,631.85; approval of transfers from the general fund to the vocational education fund in the amount of \$30,000.00; approval of transfers from the general fund to the arrisk fund in the amount of \$15,000; approval of transfers from the general fund to the virtual education fund in the amount of \$1,000, and approval of administrators written reports. Approval of Deanna Kemp's leave of absence as para professional, retirement of Karen Tennison as para professional at the end of the 2021-22 school year, resignation of Holly Borsdorf as elementary secretary effective 3/11/2022, resignation of Michelle Hofman as para professional effective 2/25/2022, hiring of Darrin Godfrey as assistant baseball coach for the 2021-22 season and Brent Slade as assistant high school track and field coach for the 2021-22 season.

Jacob Durkes moved, seconded by Jon Deters, to approve the Midwest Coating option 2A for the roof upgrade. Motion passed 6 to 0.

Policy updates were discussed but not approved.

HTK agreements were discussed but not approved.

Jacob Durkes moved, seconded by Jon Deters, to go into executive session at 7:39 p.m. to discuss administrator contracts pursuant to non-elected personnel exception under KOMA and that they return to open session in the same room at 7:54 p.m. Motion passed 6 to 0.

The meeting reconvened in open session at 7:54 p.m.

Jacob Durkes moved, seconded by Chris Campbell, to go into executive session at 7:56 p.m. to discuss administrator contracts pursuant to non-elected personnel exception under KOMA and that they return to open session in the same room at 8:06 p.m. Motion passed 6 to 0. The superintended also attended.

The meeting reconvened in open session at 8:06 p.m.

Nick Beasterfeld moved, seconded by Mistina Kraus, to go into executive session at 8:07 p.m. to discuss administrator contracts pursuant to non-elected personnel exception under KOMA and that they return to open session in the same room at 8:17 p.m. Motion passed 6 to 0. The superintendent also attended.

The meeting reconvened in open session at 8:17 p.m.

Jacob Durkes moved, seconded by Tuff Stephenson, to approve the 2022-23 administrator contracts as follows; Amy Johnston as the Elementary Principal, Randy Wild as the JH/HS Principal and William Clark as the Superintendent. SPED Director is removed from the Superintendent contract and the contract of Rodney Hasenbank's will be non-renewed at the end of the 2021-221 school year. Motion passed 6 to 0.

The efficiency audit of the food service program was discussed. At the next board meeting, the board would like to look at any past survey results from students in regards to meal choices and quality.

Jacob Durkes moved, seconded by Nick Beasterfeld, to approve the district office upgrades (\$74,586) as presented with the addition of replacing the north windows in the conference room (\$23,750). Motion passed 6 to 0.

The 2022-23 school calendar was reviewed.

Technology Coordinator job description was reviewed.

Jacob Durkes moved, seconded by Nick Beasterfeld, to approve the 2022-23 out of district request as presented. Motion passed 6 to 0.

The superintendent gave a COVID-19 update.

Mrs. Johnston and Mr. Wild gave building and program reports.

Tuff Stephenson moved, seconded by Mistina Kraus, to approve the resignation of Amanda Glotzbach as 7-12 math teacher at the end of the 2021-22 school year, hiring of Patrick Stevenson as elementary teacher beginning with the 2022-23 school year and hiring of Cade Fiske as the assistant high school track and field coach for the 2021-22 season. Motion passed 6 to 0.

Tuff Stephenson moved, seconded by Jon Deters, to adjourn the meeting. Motion passed 6 to 0. Meeting adjourned at 9:10 p.m.

Early Childhood At Risk 4 & 3 Year Old Screenings will be conducted for children ages 3 - 5 who reside in USD #330 Mission Valley school district. Below are areas listed that qualifies a student for "At Risk":

- Poverty (qualifies for free meals under the National School Lunch Program)
- Single parent families
- Kansas Department for Children and Families referral
- Teen parents
- Either parent is lacking a high school diploma or GED
- Limited English proficiency
- Child experiencing homelessness
- Developmental progress of the child has been determined to be lower than typically expected for his/her age, yet above what would be onsidered eligible for special education services

If no suspected delays are present, information about possible peer model slots will be provided.



Mission Valley started up a powerlifting club this winter with the help of Coach Vanderbilt. It gives students that do not compete in a winter sport the opportunity to workout after school and compete in a few powerlifting meets around the area. Basketball and wrestling athletes can compete in meets if they choose to do so, but most meets conflict with their regular season schedules.

This is a great motivator to get more students in the weight room. These kids put in a lot of time and effort. Powerlifting is just like wrestling and athletes compete in weight classes and have womens and mens divisions. Lifters perform a max on the bench, squat, and clean. Providing Services and Supports to Children with Developmental Delays and Their Families

Have you ever wondered if your child plays like other children her age?

Have you felt like your toddler's behavior is getting out of control?

Does your child get frustrated when you can't understand him?

Infant Toddler Services, also known as Tiny-K, provides services to Infants and Toddlers with developmental delays and their families. 
