Success Stories

Board member Holly Allen thanked the District for allowing the use of soccer fields at the High school and Middle school for the Yellowstone Cup. 150 teams from the western United States participated. This is the largest youth soccer tournament in Idaho. Mr. Lords informed the Board of a Grant received. The Grant was written by Rick Croft, Madison Cares Clinical Director, and awarded in the amount of \$80,000. Mr. Croft plans to use the grant for suicide prevention at the High school and Junior High by implementing a student led program called "Hope Squad". Board members would like updates on this program.

Bond Projects Update

Mr. Lords reported that the Adam's Elementary addition is progressing. Red brick is being added to the exterior and steel rafters are being installed. The remodel of the bathroom is slightly behind schedule. Bids for the bathrooms at the Baseball/Softball fields will be open sometime this fall.

Baseball/Softball Infield Bids

Three contractors attended the bidder walk-through for the infields at the baseball/softball complex. Only one company submitted a bid. Mr. Pyper made a motion to accept the bid from Thompson Excavation in the amount of \$228,366.50. The motion was seconded by Mr. Egbert and passed unanimously.

Hibbard Elementary Discussion

Mr. Lords asked Board members to begin discussions for the eventual improvement of facilities at Hibbard Elementary. Mr. Pyper commented on the need to be proactive. Board members would like enrollment numbers for Pre-K to 6th grade. Mr. Lords informed Board members that

the 2020 Census numbers will be available August 16, 2021. Board members also stressed the need to not increase the current Levy rate to Madison patrons.
