The Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records.

Student Education Records Access and Amendment Procedure

Reviewing an Educational Record

The District will comply with a parent/guardian/eligible student's right to inspect educational records. This right is granted using the following procedure:

- 1. A request to view an educational record shall be granted by the deadline in law (45 days).
- 2. A request may be orally or in writing to the building principal.
- 3. The principal shall notify the parent/guardian/eligible student of the time and place when a record may be inspected.
- 4. The principal or designee shall be present when the parent/guardian/eligible student reviews the record.
- 5. If circumstances prevent a parent/guardian/eligible student from reviewing the educational record at the school office, the District shall prepare and mail a copy of the record or make alternative arrangements for the parent/guardian/eligible student to review the record. Any expense incurred from copying and/or mailing a record may be charged to the parent/guardian/eligible student at state rates, except as prohibited by law.

Amending an Educational Record

A parent/guardian/eligible student has the right to request an amendment to any portion of the educational record s/he believes to be inaccurate, misleading, or in violation of the student's right to privacy. A parent/guardian/eligible student shall use the following procedure to dispute or request an amendment to an educational record. The procedure shall not be used

to dispute a grade, disciplinary decision, or opinions/reflections of a school official contained in an educational record.

- 1. Any request to amend an educational record shall be made in writing and submitted to the building principal.
- 2. The principal shall review the request within a reasonable time and approve or deny it. The principal's decision shall be submitted to the parent/guardian/eligible student. If the principal denies the amendment request, s/he shall inform the parent/guardian/eligible student of his/her right to request an appeals hearing.
- 3. Requests for an appeals hearing shall be submitted to the Superintendent. The hearing shall be held within a reasonable time after the appeal request has been made.
- 4. The Superintendent shall serve as the hearing officer. A representative of the parent/guardian/eligible student's choosing may accompany the parent/guardian/eligible student at the parent/guardian/eligible student's expense. The parent/guardian/eligible student shall have a full and fair opportunity to present evidence related to the amendment request.
- 5. The superintendent's decision is final and binding and shall be submitted to the parent/guardian/eligible student at a reasonable time after the hearing.
- 6. If the superintendent denies the amendment request, s/he will notify the parent/guardian/eligible student within a reasonable time of his/her right to submit a written response commenting on the contested material and/or explaining the disagreement with the hearing officer's decision. This written response shall be retained and, when applicable, disseminated in accordance with law.

Directory Information

The district may disclose directory information without parental/guardian/eligible student consent if it has given parents/guardians/eligible students reasonable amount of time to optout of directory information release. Opt-out forms should be provided at the beginning of the school year and when a student otherwise enrolls in the District. These forms shall contain a reasonable deadline of at least 10 days for parents/guardians/eligible students to opt out.

Directory Information is defined as personally identifiable information contained in a student education record that is generally considered not harmful or an invasion of privacy if disclosed and includes:

- a. Address
- b. Date and place of birth
- c. Dates of attendance
- d. Degrees, honors, and awards received

- e. Grade level
- f. Most recent school attended
- g. Name (first and last)
- h. Participation in officially recognized activities and sports
- i. Photograph
- j. School email address
- k. Student identification number if it cannot be used alone to access an educational record and is not the student's social security number
- I. Telephone listing
- m. Weight and height of members of athletic teams

15.1-21-08.1. Parental directive - Administration of tests and assessments - Report.

A student's parent may direct the school district in which the student is enrolled not to administer to the student any state test or state assessment required in accordance with section 15.1-21-08.

Procedure for Completing the Parental Directive Process:

- 1. Each school district shall post the Department of Public Instruction's Parental Directive form on its website and make the form available to a parent, upon request.
- 2. The form may be used for the ND State Assessments, ND State ACT, or ND Alternate Assessments (listed on SFN 61287). The form may also be used for any other specific test or assessment that could be administered to the student, except those listed in section 3. It is the school's responsibility to inform parents of the assessments used. The specific assessment will need to be typed under *Name of Assessment* in the form (i.e., Other interim assessment, Math).
- 3. The parental directive **does not apply** to:
 - Any test or assessment required by the student's school district of enrollment or this state for the completion of any grade from kindergarten through twelve or
 - Any test or assessment required by the student's school district of enrollment or the state for high school graduation.
- 4. A parental directive is valid only if it is presented to the school district using the standardized form, prepared by the Department of Public Instruction, and signed by the student's custodial parent.
- 5. One form must be completed for each student for each individual assessment. A parental directive is valid only until the conclusion of the school year in which it is received by the school district.
- 6. A parental directive submitted to a school district in accordance with this section must be retained as part of the student's educational record.
- 7. At the time and in the manner directed by the superintendent of public instruction, each school district shall provide a report regarding:
 - The number of parental directives received;
 - The number of parental directives applicable to students who are economically disadvantaged, students from major racial and ethnic groups, students with disabilities, and students with limited English proficiency; and
 - Any loss of funding stemming from the parental directives.
- 8. A school district is not liable for any consequences incurred by a student as a result of a parental directive submitted in accordance with this section.
- A school district is not required to provide instruction or activities for a student during the administration of any test or assessment referenced in the parental directive submitted by the student's parent.

Annual Asbestos Notification to Parent, Students, and Employees of the North Star School District

Asbestos is a naturally-occurring mineral which has, until about 1980, been commonly used in building materials. Asbestos will not burn, is an excellent insulator, has great strength, is resistant to chemicals, and absorbs sound. Examples of asbestos-containing building material (ACBM) are vinyl floor tile, sprayed-on acoustical ceiling material, and pipe insulation. As ACBM deteriorates over time, or is disturbed by maintenance, renovation, or demolition activities, asbestos fibers may be released into the air. Inhalation of these airborne, microscopic fibers has been proven to cause such deadly diseases as lung cancer, mesothelioma (cancer of the lining of the lungs), and asbestosis (scarring of lung tissues). Uncontrolled asbestos contamination in buildings has been, and remains, a significant environmental and public health issue. In 1986, Congress enacted the Asbestos Hazard Emergency Response Act (AHERA) to require public and private, secondary and elementary schools to identify ACBM in their school buildings and take appropriate actions to control the release of asbestos fibers. In 1987, the US Environmental Protection Agency finalized a regulatory program which enforces the AHERA mandate. These regulations are incorporated within the AHERA Rule (40 C.F.R. Part 763, Subpart E).

In compliance with the AHERA Rule, the North Star School District had its building inspected by an asbestos inspector, accredited by the State of North Dakota. During that inspection, areas of suspect ACBM were identified. The type, condition, and location of this ACBM were noted. These materials are found in certain areas within the school. A complete list of these can be viewed upon request at the school during normal office hours.

Upon confirmation of the presence of ACBM, an Asbestos Management Plan has been developed. The Asbestos Management Plan includes a description of the measures currently being taken to ensure that the ACBM remaining in our school building is maintained in a condition that will not pose a threat to the health of our students and employees.

Information is provided on the periodical monitoring of the condition of the ACBM remaining in our school building through triennial re-inspections conducted by an accredited asbestos inspector, and through semi-annual surveillance, conducted by trained school maintenance staff.
