Dr. Jancek held the first reading of IASB PRESS Plus Policy Update recommendations for both Boards. The Boards have already decided that they will not be approving Policy 6:60 Curriculum Content, which deals with new standards for sex education in schools. These updates will be brought back to the next meeting for approval.

Dr. Jancek presented the proposed 2022-23 school calendar for approval. This calendar closely mirrors the Pontiac school calendar so that we may line up our students with LACC and LCSSU services.

He recommends that decisions on masks should be made by the individual student or their parents, so he proposes that we still recommend the use of masks, but that staff and students may go mask optional at this time. The only exception to this recommendation is when students and staff are on District transportation, where masks are federally mandated.
