Black Butte Union Elementary held a public hearing on September 14, 2021, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

The School Site Safety plan, which is a living document, was reviewed on October 20, 2021. All revisions will be communicated to both the classified and certificated staff. The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire and disaster drills are conducted on a regular basis throughout the school year. Lock down drills are held as needed. Students are supervised before and after school, and during lunch. There is a designated area for student drop off and pick up. To ensure the safety of students and staff and avoid disruptions, all visitors shall register in the school office immediately upon entering any school building or grounds when school is in session. Visitors will be issued a visible means of identification while on school premises.

2020-21 Types of Services Funded

All Classroom Teachers; Attend monthly Professional Learning Committee (PLC) staff and grade level meetings to review student assessment results, attendance, and teaching strategies. All teaching staff have also been learning about Multiple Tiered System of Supports (MTSS), and Universal Design for Learning (UDL) strategies. Shasta County Office of Education has been providing staff development support for increasing positive student attendance data and support along with academic support in Mathematics, English Language Development, and in reviewing new California Science Standards Science Curriculum.

New Teacher (e.g., Alliance for Teacher Excellence (ATE); At this time we have no new teachers needing this support system. When new teachers are hired the district supports the ATE program.

Non-Classroom Teachers; The district has one Intervention Teacher that attends all staff and grade level PLC training's and meetings. The intervention teacher is also on the MTSS team that receives specific training and brings that information back to the teaching staff. The intervention teacher also attends training offered through the Shasta County Office of Education on the California Assessment of Student Performance and Progress (CAASPP) coordination and any other pertinent training's that are offered regarding teaching strategies, academic, or social/emotional development.

National Board Certified Teachers; Currently the district has none.

Teachers experiencing difficulty/in need of improvement (Peer Assistance and Review); Teachers are evaluated every other year unless a "Need of Improvement" category has been identified. Should that occur a corrective action plan is developed and followed with other formal reviews. The plan may involve peer review, coaching from outside source, and/or specific professional development in the area in need of improvement.

Paraprofessionals (e.g., instructional aides, teacher assistants); Staff development is offered throughout the year through the district, on-line, or the Shasta County Office of Education.

Non-instructional support staff (e.g. clerical, custodial, transportation). Staff development is offered throughout the year through web-casts, CDE, and Shasta County Office of Education. Bus drivers must receive 10 hours of training per year through a certified transportation instructor. These training's are offered through the Shasta County Office of Education transportation department or privately contracted through the school district.

Professional Development

The primary factors for determining professional development is based on reviewing student data including classroom formative assessments, K-3 Reach Higher reading and math assessments, Aims-Web reading and math assessments, I-Ready reading and math assessments and reviewing the California Assessment of Student Performance and Progress (CASSPP) results. Student attendance and discipline records are also reviewed on a regular basis.

The school calendar has ten early release days scheduled, dedicated to Professional Learning Collaboration meetings, and three full days dedicated to professional development spread throughout the school calendar year. The school administrator and two teachers are participating with ongoing training on Multi-Tiered System of Supports (MTSS) and Universal Design for Learning (UDL). The team then brings that information back to the staff during PLC meetings. All staff are also making positive student attendance a priority with the district receiving support from the Shasta County Office of Education. We are reviewing attendance data, academic achievement, student engagement strategies, and how to improve and increase school to home communication regarding student attendance. All teaching staff have also participated in professional development activities related to social/emotional development which includes Fred Jones "Tools for Teaching", Capturing Kids' Hearts, Trauma Informed Instruction, ALICE, Interim Assessment workshops, and Restorative Practices. Shasta County Office of Education (SCOE) also provides various opportunities throughout the school year in the areas of math, language arts, writing, science, and technology, that are offered during the school day or in afternoon sessions. Summer professional development opportunities are also offered through SCOE.
