

Axtell Community School Chromebook Loan Agreement

The below listed items are being loaned to the student and are in good working order unless otherwise indicated. It is the responsibility of the student to care for the equipment and ensure that it is retained in a safe environment. A \$35 usage fee is assessed to cover the cost of a service agreement, battery replacement, maintenance, etc. This must be paid before the Chromebook will be allowed to go home with the student. The usage fee is non-refundable.

The service agreement covers components installed at the time of purchase, including the central processing unit, integrated optical drive, integrated keyboard, integrated LCD screen, and other features provided at the rental date listed above.

The service agreement does not include intentional misuse, modification, an unsuitable physical or operating environment, improper maintenance, theft, loss or damage from fire, flood or natural disaster.

This equipment is the property of Axtell Community Schools [ACS], and is herewith being loaned to the student for educational purposes only for the academic school year. Students may not deface or destroy this property in any way. Inappropriate material on the machine may result in the student losing their right to use this Chromebook. The equipment will be returned to the school on a date to be determined or sooner if the student is discharged from the school prior to the end of the school year.

If this equipment is lost, stolen or damaged while in the borrower's possession, the borrower is responsible for the replacement or repair thereof and the borrower agrees to indemnify ACS from any claim occurring during or resulting from the borrower's possession or use of the ACS property, including, but not limited to, any claim for infringement or violation of applicable trademarks and copyright attributable to the borrower's use of ACS property.

This borrowed equipment may be used only for non-commercial purposes in accordance with ACS policies and rules. Any included software may be used only in accordance with the applicable license is the borrower's responsibility to be familiar with and comply to the provisions of such license.

The borrower may not install or utilize any software in connection with the borrower's use of this equipment other than software owned by ACS and made available to the borrower in accordance with this receipt and agreement. The borrower agrees not to make any unauthorized use of or modifications of such software.

ACS is not responsible for any computer or electronic viruses that may be transferred to or from the borrower's data storage devices. The borrower agrees to use the borrower's best efforts to assure that ACS property is not damaged or rendered inoperable by any such electronic virus while in the borrower's possession.

The borrower acknowledges and agrees that the borrower's use of this equipment is a privilege and that by the borrower's agreement to terms hereof, the borrower acknowledges the responsibility of the borrower to protect and safeguard this equipment and to return said equipment in good condition and repair.
