Ready for Learning District Support Plan 2022-2023



*Pangburn School District will update the guidebook as additional public health guidelines are provided. Revised 4/13/2023

Face Coverings -Individuals may choose to wear a mask if it's their personal choice.

Health Screenings - The district is committed to trying to conduct our daily activities as safely as possible and will use the following guidelines.

- Parents should take their child's temperature each day before coming to school. Anyone with a temperature of 100.4 or higher should not go to a school site.

COVID Home Testing -

- The district strongly encourages additional testing for students and staff who test positive for COVID using a home COVID test.
- It is the responsibility of the parent, student, or staff member to report a positive home COVID test result to the Department of Health.

Isolation - Positive COVID-19 Case -

Isolation is appropriate for someone who has tested positive for COVID-19, regardless of vaccination status. The CDC recommends that a person should:

- Stay at home for at least 5 days
- If you have no symptoms or your symptoms are resolving after 5 days, you can leave your house (return to school).
- Recommended to wear a mask around others through the 10th day of isolation.

If you have fever, continue to stay home for 24 hours after fever has resolved.

Quarantine- Personal Close Contact -

2/22/22- During the regular school board meeting, the school board established that the District will no longer contact trace students and staff who are close personal contacts to a positive COVID case.

Visitors to the campuses -

Any visitor must check in in at the building office before entering and must have essential business.

Communication -

Pangburn knows that communication with stakeholders is essential as we work through this pandemic. We will communicate with our stakeholders in the following manners:

- We will communicate through email.
- We will be using our school app to push out notifications and information.
- We will be using our school website pangburnschools.org to send out information.
- We will be using our school Facebook page to send out information.
- We will be using our Ready for Learning committee to evaluate situations as we move forward and to disseminate information.

Teaching and Learning -

On-site Instruction -

Pangburn will offer on-site instruction for students which will also include the use of Google Classroom (Grades K-6) and Spark (grades 7-12) to allow students and teachers to be prepared if there is a need to pivot from on-site to virtual instruction. Pangburn will be ensuring a guaranteed and viable curriculum for all students. This platform will allow students to continue learning grade level or content standards through an educational plan that leverages both the technology-based and face-to-face instructional approaches. We will use diagnostic assessments to provide instructional support for our staff and those will assist in identifying the learning needs of each student.

Diagnostic Testing -

Pangburn will use Dibel, Star, Past, Lexia and/or DSA as the source for diagnostic assessments for all of our onsite students to provide teachers information regarding gaps or delays that might be present

Unfinished Learning -

Pangburn is aware that the recent pandemic over the past 3 semesters has caused a learning loss in many of our students and we will be using certified interventionists to individually assess and work with any gaps that have been detected using the diagnostic testing.

Learning Management System -

As was mentioned above, Pangburn will use Google Classroom (Grades K-6) and Spark (grades 7-12) as the main platforms to deliver instruction to our students in the event of a shut down.

Logistics -

In the event of a long term shut down of a classroom, building, or district, any family without internet access at home may be provided with a district hot spot to be used for educational purposes.

Student Services –

Social and Emotional Services -

- On-site counseling services will continue to be provided by district counselors.
- Mental health services will be continued through the provider at the parent's discretion.
- Special education services will be provided to on-site.
- Dyslexia services will be provided to on-site.

Attendance – defines a student absence as not present for on-site instruction provided by the district; not participating in a planned district-approved activity, or not engaged in scheduled instruction at an off-site location. Absences for students that test positive will follow the same absentee policy as defined in the student handbook.

Extracurricular Activities

Pangburn will follow the guidelines in place by the Arkansas Activities Association (AAA) and the Arkansas Department of Health (ADH) in regards to participation and policies. All students are eligible for participation in extracurricular activities if they meet the eligibility requirements of the AAA.

Maintenance & Transportation -

Transportation: The District will run our regular bus routes Monday through Friday.

- Students will have assigned seats on the route with family units sitting together.
- Each bus will be sanitized on a regular basis.
- The district will follow the latest guidelines set by the ADH and DESE.

Cleaning/Sanitation –

Pangburn School is committed to keeping our students and staff safe. We will be using the following protocols:

- All buses will be sanitized on a regular basis.
- Custodial staff will sanitize areas of high traffic on a regular basis throughout the school day.
- Restrooms will be sanitized on a regular basis throughout the school day.
- Touchless water bottle filling stations will be available in all buildings. We encourage parents to provide their children with water bottles to bring daily.

Food Service – Procedures: Breakfast and lunch will be served to Pangburn students under the following guidelines:

- Breakfast: Students in grades K-2 will be in the classroom, grades 3rd-6 and 9-12th will have a grab-n-go style breakfast; Students in grades 7- 8th in the cafeteria.
- Lunch: Students in grades 1st-12th will be in the cafeteria; PreK & Kindergarten will eat lunch in the Elementary safe room.

ESSER Funds Committee –

ESSR Funds Review

ESSR Funds come in 3 Installments ESSR I, ESSR II and ARP ESSR.

ESSR I - (\$85,033.70) was primarily used to get schools started after the mandatory closures in Spring of 2022. PPE, mask, thermometers, hot spots for virtual learning were the primary expenses of the district

ESSR II- (\$380,488.32) was used to continue learning during the pandemic. 7 para positions were funded to social distance to avoid mask wearing, prometean boards were purchased for teachers, Chrome books for each teacher to use at home.

Other expenses were moved out of general fund to ESSR to allow for a \$550 raise in 2021 and a \$450 raise for bachelors and \$650 raise for master's level in 2022 above the minimum salary schedule. We also gave classified staff the same percentage raise.

ARP or ESSR III- (\$855,463.41)- Majority on learning loss and summer school. For School Year 2023- \$404,000 Left in ARP Funds. The recommended bonus would cost the district \$625,000.

We have 3.75 Certified Salaries and benefits and 1 Classified Salaries and Benefits are tied to this fund for SY 2023-2024.

Community and Staff Input for spending needs came from Ready for Learning Committees in the summer meetings in 2021 and 2022, PPC Meetings, Grade Level Meetings in K-6 with district office, and surveys with parents, staff and other stakeholders including one that is posted to the website.
