TAB 9 - PRICE PROPOSAL

ANet is a mission-driven nonprofit organization focused on students. The price that partners pay for ANet's service model covers only a portion of the total cost of our services, and ANet raises money at the national level to help keep our work affordable for our partners. Our average cost per school for Full Partnership is \$43,000 while the price we charge that school is \$33,000. The cost of ANet's services includes all overhead expenses and indirect costs. Our standard approach to pricing is to charge on a per school basis for our Full Partnership.

Full Partnership: \$33,000 per school, per year

- Roughly 20 job-embedded coaching interactions
- Quarterly ANet interim assessments in math and ELA for grades 2-11, transadapted Spanish math assessments in grades 2-8, and Spanish Language Arts (SLA) assessments with authentic Spanish texts in Grades 2-5.
- Unlimited access to myANet reports and instructional resources
- Invitations to group professional learning events.
- Additional fees may apply for:
 - Grade 2-8 enrollment between 301 and 500: \$3,300
 - Grade 2-8 enrollment > 500: \$6,600
 - Support of High Schools (regardless of enrollment): \$5,000

System Alignment: \$33,000

- Roughly 20 job-embedded coaching and professional development interactions that include: system-level progress monitoring, professional learning, thought-partnership, and planning to implement ANet's partnership in support of the district priorities.
- Unlimited access to myANet reports and instructional resources
- Invitations to group professional learning events.

ANet will work alongside Bernalillo Public Schools to determine which schools should receive our school-based Full Partnership. ANet will also provide our System Alignment partnership to support the district in advancing system-wide priorities and ensure that professional development is aligned across all schools.
