9. DISCUSSION:

9.1 Approach to hiring Varsity Coaches

After much discussion the board agreed to review and change the way the varsity coaches are hired. They agreed to advertise each open position to the public, not just inhouse. They agreed we need to have a committee (head coach should be on the committee for assistant coach) and hire the most qualified. That there will be consistency of interviewing and hiring.

9.2 Budget

Matt presented the budget highlights to the board. He stated that 75%-80% of the budget is salary and explained that our standard step is a 2.1% raise and have added a 3% COLA, which is still below inflation rate. Trying to be competitive as a state as well as with Utah and Wyoming. Continued to explain that our budget is on the conservative approach and our reserves are strong.

9.3 Approach to Security

The board discussed having specific staff with concealed weapons permits as part of the needed security of the buildings. The board agreed to go forward with pursuing this with training. Matt will move forward by meeting with the police and sheriff's departments, will be thoughtful about it and he thanked the board for their support.

9.4 Activity Mill Levy with Recreation District

The recreation district board met and agreed to move forward if the school district agrees. Both district's need to meet, together to discuss. Would like to meet at the Rec. Center on Monday, July 11th at 6pm. Will send out an email asking if that date will work or if we need to move to a different date and time.
