This audit included a review of the federal funds provided to the RSU due to COVID; the audit shows the spending was all appropriate.

The Grant Programs were reviewed as well with "no findings".

b. Extended Learning Opportunities (ELO) presentation by Jessica Greene and Shannon Mathers. Jessica and Shannon shared a presentation for the new program: Extended Learning Opportunities.

These courses are hands-on, credit-bearing learning opportunities that students will be able to access in high school and may include local businesses, CTE courses and other venues. Often these individualized programs will offer certifications and/or dual credit as well as enhance life-long choices and decisions.

- c. Presentation by Joe Fagnant, RSU 29 Adult Education Director. Mr. Fagnant presented an overview of the many opportunities available by becoming part of the area program. Adult Education is housed at the Houlton Higher Education building on Bangor Street in Houlton. This encompasses seven major programs: NMCC, Region CTE, Workplace Development, Enrichment programs, HiSET, Maine College and Career Access, as well as an outreach program for learning at the Aroostook County Jail. The area Adult Education is also part of a HUB encompassing adjacent counties. This partnership with HUB offers the opportunity to expand and assist with current workforce shortages.
