#### ARKADELPHIA BOARD OF EDUCATION

Regular Board Meeting Minutes February 15, 2022

The Arkadelphia Board of Education met in regular session on Tuesday, February 15, 2022, at 6:00 p.m. in the upstairs conference room of 700 Clinton Street Arkadelphia, Arkansas. The meeting was called to order by Mr. Bell. A quorum was established with six members present.

## **CONSENT AGENDA**

- a) The minutes from the January 18, 2022 Regular Board Meeting, and the February 1, 2022 Special Called Agenda Setting Meeting were approved as submitted by unanimous consent of the Board.
- b) The January 2022 Financials were presented by Tammy Barger.
- c) The 2020-2021 Audit by Arkansas Legislative Audits was discussed.
- d) Ida Tramble, Board Secretary, reviewed the results of the Board Self Evaluations.

## **ACTION ITEMS**

- a) Approval of a One-Time (non-recurring) Payment to all ASPD Contracted Employees
  Upon the recommendation of the Superintendent a motion was made by Ms. White, seconded
  by Mr. Tennyson, and carried 6-0 to approve the one-time payment of \$750 to all APSD
  Contracted Employees.
- b) Approval of the Purchase of Iwave Air Purifiers

  Upon the recommendation of the Superintendent a motion was made by Dr. Harris, seconded by Ms. White, and carried 6-0 to approve the purchase of 150 Iwave Ion Air Purifiers from R&E Supply in the amount of \$59.093.11. The purchase will be covered by a ELC/POC grant from Dawson Coop and be installed by maintenance staff in every classroom in the district.

### c) Approval of Smartboards

Upon the recommendation of the Superintendent a motion was made by Dr. Harris, seconded by Ms. White, and carried 6-0 to approve the purchase of 17 Smartboards using Title I funds in the amount of \$48,944.40 for Peake and Goza.

## d) Approval of Policy 3-1 Stipend Schedule

After some discussion a motion was made by Dr. Harris, seconded by Mr. Tennyson, and carried 6-0 to approve tentatively with a 30 day read and bring it back on March 15 in the regular Board of Education meeting.

## e) Revisit Mask Mandate

Upon the recommendation of the Superintendent a motion was made by Dr. Harris, seconded by Mr. Tennyson, and carried 6-0 to make the wearing of masks optional at APSD campuses.

# f) Superintendent Contract

It was the consensus of the board to discuss the Superintendent's contract and the next item of personnel in executive session.
