IMMUNIZATIONS REQUIRED BY MISSOURI LAW

According to Missouri State Law 19 CSR 20-28.010, IMMUNIZATION REQUIREMENTS FOR SCHOOL CHILDREN, the parent/guardian must furnish the school satisfactory evidence of immunizations against diphtheria, pertussis, tetanus, polio, measles, rubella, and mumps, 1993, Hepatitis B, 1997, 1999, varicella 2005 (entering kindergarteners who have not had chickenpox disease).
