F. District Report - Camp Verna's

Area School Principal Mike Simon and Teacher Rachel Jones presented an overview of the upcoming summer activities at Camp Verna's.

G. Action Items: New Business

1. Bid Award for CTE Construction Trades Building & Authorization for Letter of Intent and Contract

It was moved by Grim and supported by Kile to approve Presler's recommendation to hire Three Rivers Corporation as the general contractor for the CTE Construction Trades building at the Magnus Center. The motion passed 5-0.

2. Bid Award for Special Education Transportation - Dean Transportation

It was moved by Murawski and supported by Grim to approve Presler's recommendation to contract with Dean Transportation as the special education transportation provider for the next three years. The motion passed 5-0.

3. Bid Award for Firewall/Content Filter - Casair

It was moved Grim and supported by Kile to approve Presler's recommendation to contract with Casair as the district's firewall/content filter software provider. The motion passed 5-0.

It was moved by Grim and supported by Maxwell to approve all contracts as presented. The motion passed 5-0.

5. Audio-Visual Upgrades to Conference Room

It was moved by Murawski and supported by Kile to approve Presler's recommendation to hire MOSS to perform upgrades to the AV equipment in Conference Room A/B at the CGRESD Central Office building. The motion passed 5-0.

H. Administrative Information Items: Superintendent's Administrative Report

Presler shared several information items, including:

- Recognizing and thanking several audience members for attending: Ruth Sandridge and Lisa Cooper, Speech Language Pathologists; Matt Smith, School Psychologist; Corrie Aldrich, Certified Occupational Therapy Assistant; Candance Opalewski, Business Management Teacher/Work-Based Learning Coordinator; and Don Kolander, Dean Transportation Driver.
- CGRESD has received official notice of accreditation from AdvancED; certificates will be hung at the CGRESD and Area School.
- An update on CTE was delivered, including Presler's appearance at the most recent Beaverton Lions Club meeting, where she heard several positive comments about CTE and met a local business owner who is hosting two students in the Work-Based Learning program. Presler also noted positive performances by students in recent CTE statewide competitions and shared a document outlining CTE's Year in Review.
- At the Area School, construction work on the new playground pavilion is complete. One picnic table will be purchased by the PTO, and another has been donated by the Harrison Moose Club.
- Voters in the Harrison Community Schools district approved its recent bond proposal, opening the door for \$26.7 million in repairs and upgrades to facilities and

- infrastructure. Presler recognized CGRESD Communications Director Rusty Govitz for his leadership in the informational campaign strategy and communications for the proposal.
- The Area School will see several improvements this summer, including a new well, a window in the classroom that doesn't have one, and additional fencing behind the garage.
- A new well tank will be installed at the RESD office building.
- Exterior lighting at the office and Area School buildings and the lighting in the Area School gym will be changed out for higher-efficiency lighting. This initiative is part of a larger examination of the RESD's long-term maintenance and replacement schedules.
- Presler's legislative update included concerns over several funding issues, including federal funding for S.P.A.R.K.S.; the state's allocation to the general fund versus the school aid fund; the 2x formula that affects all five local districts; at-risk funding; CTE equipment funding; and the employee retirement program MPSERS.
- Upcoming dates to note include the groundbreaking photo op for the new Construction Trades building on Wednesday, May 24 at 9 a.m.; the CGRESD board election on June 5 at 5:30 p.m.; and the Area School graduation on June 6 at 1:00 p.m.

I. Board Comments

Grim offered praise for students, teachers and administrators for both the CTE Awards ceremonies and the CGRESD Turnaround Luncheon.

Maxwell reported his comfort level with the bidding process for the new Construction Trades building.
