- H. Administrative Information Items: Superintendent's Administrative Report Presler shared the following Good News:
 - SPARKS grants for 6 additional sites at local district middle and high schools were secured! An additional \$810,000 for each of the next five years will support the new after-school and summer school programs starting this fall. Clare-Gladwin RESD was one of just three entities in the state that secured two grants, and the amount we're receiving comprises nearly 10% of the total funding available in Michigan. Kudos to the grant-writing team consisting of Rebecca Idzikowski, Keri Retzloff, Josie Ellis, Joe Trommater, Shay Anderson, and Deb Snyder!!
 - The Michigan Department of Talent and Economic Development (TED) visited our CTE Summer Camp program to take pictures and gather information for a story promoting CTE. They also plan to return in the fall to shoot a promotional video!
 - Elaine Reinke attended a job fair at SVSU and brought back 8 resumes for new SPARKS positions! Elaine's attendance at various job fairs has led to several hires for positions at CGRESD.
 - The Area School staff planned and put on another great end-of-year program for the four graduates!
 - The Business Office has processed all of the refunds for the 3% collected by the state from employees for retirement healthcare! This was a time-consuming and unexpected task that was completed in a timely and accurate manner. Thanks to Shay Anderson, Holly Resseguie, Lisa May, and Josie Ellis!

Presler reported on the following:

- The Legislature passed and the Governor was expected to sign (and he did) the School Aid Budget. ISDs received a 2% increase to Section 81, our general operations funding. For CGRESD, this is an increase of less than \$10,000. We are learning as much as we can about the Marshall Plan which promises additional funding for CTE. Our local districts will be receiving an additional \$240 per student for the 2018-2019 school year.
- There are several buildings and grounds projects planned for this summer, some of which had already been completed by the date of the meeting. They include:
 - o Replacing the parking lot lights with LED lights that are brighter and more energy efficient
 - o Installing a sink and cabinetry in the nurse's room at the Area School
 - o Repairing the bottom of the columns in front of the Area School
 - Replacing the classroom doors in the oldest section of the Area School (Because the wood doors have been damaged over the years by wheelchairs and other equipment, they now pose an injury hazard. The new doors have large kick-plates and edging to prevent damage to the doors resulting in wood slivers, cuts and scrapes, etc.)
 - o Replacing the gate to the Area School playground area and the woodchips
 - o Touch-up painting
 - Installing blinds on the doors of Conference Rooms A, B, and the ITV room for security purposes
- CGRESD is a site for a Michigan Association of School Boards "Get On Board" event on Wed., July 11 from 6:30-7:30. This is an effort to inform community members about what it means to be a Board member and to encourage community members to get involved.
- Presler mentioned the annual Northern Michigan School Legislative Association dinner which will be held on Thursday, August 2 in Traverse City. She will share more details with the Board as they become available.
