## LETTER TO ATHLETES OF GREENWOOD MIDDLE/HIGH SCHOOL

The purpose of this letter is to provide information about the athletic training services provided by Marshfield Clinic Health Systems, Inc. at Greenwood Middle-High School.

Marshfield Clinic Health System, Inc. has been selected by Greenwood School District to provide athletic training services at Greenwood Middle-High School at no cost to the student athletes or the school except for a charge to offset Clinic's administrative costs to provide the services.

Marshfield Clinic Health System, Inc. is a not-for-profit corporation that will provide these services to the young athletes of the school with a goal of providing education in the prevention of sports related injuries.

Marshfield Clinic Health System, Inc. athletic trainers will assist the school in the creation or development of a sport medicine program for the improvement of the care of injuries to student athletes and the prevention of such injuries. The athletic trainers will evaluate injuries sustained by student athletes and will either recommend treatment or provide the athlete with a list of health care providers in the area that offer services appropriate to the athlete's injury.

Marshfield Clinic Health System, Inc. is not seeking to encourage the referral of student athletes to Marshfield Clinic Health System, Inc. for injury follow-up or other healthcare services. The provision of athletic training services is in no way intended to influence the athlete's or his/her parent/guardian's judgment in choosing a health care provider that is best qualified to provide medical care to the athlete. There is no requirement that the student athlete receive follow-up care at Marshfield Clinic Health System, Inc. as a condition to receiving the athletic training services provided at Greenwood Middle-High School.
