


- Some aging building systems need updating

- As good stewards of taxpayer resources, we recognize the financial window of opportunity








# **Facilities Planning Timeline 2021-2022**

The District's share of property taxes is calculated using a mill rate. Since 2013-14, our tax mill rate has dropped **nearly 25**%.



Our tax rate compared to schools in our conference is near the bottom, and is well below the state K-12 average of \$8.67.



# What is the recommended plan?

The proposed referendum plan addresses the identified needs in our facilities planning and impacts <u>all students at both</u> <u>school buildings</u>.

Question 1 addresses improved safety, security, and accessibility; aging infrastructure, and outdated educational spaces at both the Elementary and Middle/High Schools.

**Question 2** is for HVAC work and air conditioning at the Middle/High School.





# **Two Questions on the April 5 Ballot**

**Question 1 - \$15,600,000** for educational improvements, including a classroom addition, renovations, safety, and security improvements, building infrastructure and site improvements at the Elementary School; as well as renovations, safety and security improvements, accessibility updates, and infrastructure, site and outdoor athletic facility improvements at the Middle/High School.


**Question 2 - \$2,300,000** for HVAC upgrades including air conditioning at the Middle/High School.



## What is the estimated tax impact?

If voters approve both measures, the combined estimated maximum tax impact is \$0.78 per \$1,000 of fair market property value, or \$78.00 a year on a home valued at \$100,000.

# **School District of Wild Rose**Historical and Projected Mill Rate



The District made its final debt payment on prior debt this year. If the referendum is successful, the District tax mill rate will have an estimated \$0.78 increase. This means that the portion of property taxes that are allocated to the School District would increase by an estimated \$78 annually (or \$6.50 monthly) per \$100,000 of fair market property value. This increase would be reflected on the December 2022 tax bill.

Debt issue are amortized over 20 years at a planning interest rate of 3.75%.

Mill rate based on 2020 Equalized Valuation (TID-OUT) of \$868,239,570 with annual growth of 1.00% thereafter.

Debt borrowings are amortized over 20 years at a planning interest rate of 3.75%. Mill rate based on 2021 Equalized Valuation (TID-OUT) of \$868,239,570 with annual growth of 1.00% thereafter. Impact represents the change in the mill rate over the projected 2021-22 mill rate of \$0.60 for the energy efficiency exemption levy. Because state aid is not a major source of revenue for the District, the financing plan does not incorporate a potential impact to state aid. The District currently receives aid on expenditures at a tertiary rate of -108.46% (2021-22 October 15 certification). Planning estimates only. Significant changes in market conditions will require adjustments to current financing plan.



### **Wild Rose Elementary Projects**

Relocate/renovate Main Office to create a secure entrance to better monitor and control visitor access.

Renovate the current office space into a hands-on-learning lab.

Add classroom space, conference room, restrooms, and building storage.

Replace entire roof and repair building envelope, floors, and ceilings.


Upgrade lighting to improve energy efficiency (LED).

Update classroom furniture to create more flexible learning environments.

Resurface asphalt playground.

Site work and resurfacing the front driveway.

Replace baseball/softball backstops




- Relocate Middle/High School Office to create a secure entrance.
